#### ANNOUNCEMENT

GARZONE Racing Organization Promotion Ltd. will organise a Cross-Country Baja named "HunGarian Baja 2009" from 20<sup>th</sup> August to 22<sup>nd</sup> August 2009.

The event will take place in accordance with the following regulations, to which all drivers and competitors signing the entry form will be bound:

- The FIA International Sporting Code (and its appendices)

- The 2009 FIA General Prescriptions applicable to the events counting towards the all FIA Cross-Country Rallies and the FIA International Cup for Cross-Country Bajas. (General Prescriptions)

- Present Supplementary Regulations and its appendices
- Official bulletins
- The traffic regulations of Hungary

#### HunGarian Baja is the 4<sup>th</sup> Round of the FIA International Cup for Cross-Country Bajas 2009.

Modifications, amendments and/or changes to these Supplementary Regulations will be announced only by numbered and dated bulletins (issued by the Organiser and approved by the FIA and National Automobilsport Federation of Hungary (MNASZ) up to the time of the first stewards meeting and thereafter by the stewards).

The Baja Cup is run together with the event of the National Championships and with the event of the Open International Cup (T1,T2,T4,TH- Open Challenge)

The event is the fifth event of the National Cross-Country Championship of Hungary with coefficient two.

It is at the same time the second event of the open Czech-, and Slovak Republic National Championship for Cross-Country Rally also with coefficient two.

There will also be:-

- 1. a National and Open International Event with separate regulations and starting after all FIA competitors; and
- 2. a Motorcycle/Quad European- and National Championship event with separate regulations and used different special stages.

These Supplementary Regulations are published both in English and Hungarian. In case of dispute concerning the interpretation of the regulations, only the English text will be binding.

The official time will be as GPS (GMT + 1hr). **DST**(Daylight Savings Time)

#### 3.3 NUMBER OF ENTRIES AND CLASSES:

Crews entered for participation in the Hungarian-, Czech- and Slovak Championship Event and paid entry fees in compliance with Supplementary Regulations of the National Championship event they have to pay less entry fees for participation in this event.

#### 3.6 REFUNDS:

The organizers will reimburse the entry fees, minus a variable retainer, to competitors who were unable to present themselves at the start of the event for reason of "force majeure", subject to the application reaching the organizers by registered mail.

The deduction will be:

- of 25 % of the entry fees for the request received until 60 days before the administrative checks
- of 50 % of the entry fees for the request received until 30 days before the administrative checks
- there will always be a deduction of 10 % (file fee)

Entry fees will be repaid in full only: If the rally does not take place.

#### 4. INSURANCE

#### 4.1 TRAFFIC INSURANCE:

Third party risk insurance (Traffic insurance) is compulsory for all crews taking part in the rally. All competitors must have an insurance policy and present it at the administration checking. This insurance is valid both on road sections and special stages. Description of the organizer's insurance will be published before the administrative checking.

#### 4.2 CREWS ARE INSURED BY FOREIGN COMPANIES:

The competitors must have traffic insurance valid for Hungary.

#### 4.3 INSURANCE AMOUNTS:

The crew will get the supplement of the insurance on the Administrative Check. The insurance premium guarantees the competitor cover for civil liability towards third parties at a maximum amount of 40.000,-EUR. The organizer does not take any responsibility for the losses and the damages in regard to competitors. The competitors take part in the rally at their own risk. In case of any accident the competitor or his representative should report this fact at the next Time Control and then submit a written report to the Rally Office before the publication of the results. By the very fact of signing the entry form the crew relinquishes any rights to compensations of any kind which may occur following the incidents during the rally. This insurance does not cover their own and the second parties' racing car's damages.



#### 13. RUNNING OF THE EVENT

#### 13.1 TIME CARD CHANGE DURING THE EVENT:

The Time cards will be issued at the Start of each Leg and each Section.

#### 13.2 STARTING SYSTEM OF SPECIAL STAGES:

The timekeeping on the Special Stages will be completed to the second.

#### 13.2.1 STARTING PROCEDURE FOR THE SPECIAL STAGE will be as follows:

On the start of the Special Stage the crew stops the car at the start control, the marshal notices in the time card the actually start time of the car (hour and minutes) and the start will be given by means of a light equipment. A two digit display will show continiously the time progressing. The marshals will call outloud the 30, 15, 10 seconds then point towards the start equipment. Beginning from the 55 seconds, red lights will be flashed per every second, then at 00 seconds the red lights will go off and below, the green lights will go up. This will be the time to start.

In case the equipment goes wrong the marshals will change to manual starting procedure.

Any crew not impossible to start during the 20 seconds will be penalized with 2 minutes. If the participant can't leave the control zone the penalty may go as far as start refusal.

#### 13.2.2 Starting order

After Leg 1, and for the following legs, the start will be given following the order of the Selective Section Classification of the previous leg and every 2 minutes for the first 10 classified (art. 19.4.a of the FIA CCR General Prescriptions 2009).

If two or more selective sections have been run in the same Leg, the starting order of the next day's leg will be drawn up by cumulating the times of these selective sections.

In case of an ex aequo, priority will be given to the crew who achieved the fastest time in the 1st selective section (art. 19.3 of the FIA CCR General Prescriptions 2009).

Any delay in reporting to the start of the different Legs will be penalized at the rate of one minute per minute's delay. Vehicles arriving more than 30 minutes late will not be allowed to start (art. 19.8 of the FIA CCR General Prescriptions 2009).

#### 13.2. Early check-in at end of Leg

Early arrival at the end of Legs (1<sup>st</sup>, 2<sup>nd</sup>) time controls will not be penalized.

13.2.1. It is strictly forbidden to enter or leave a control area from any direction other than specified by the Road-Book, or to re-enter a control area once checking in has taken place at this control.

#### 13.3. Issue and collection of time cards

A time card will be given to each crew at the start of each Leg. This time card will be collected at the arrival of the same leg (Art. 33.1 of FIA CCR General Prescriptions 2009)

#### 13.4. Total distance of the course

The HunGarian Baja 2009 consists nine (9) selective sections and two (2) Legs: - First Special Stage, for the purpose of determining the starting order for the next Leg, with a distance of aprox. 50 kms.

The itinerary shall be kept secret and will be revealed to the crews only by the time of the delivery of the respective road books.

#### 13.5. Mobile telephones

For safety reasons, the use of mobile telephones in case of emergency is authorised. under Art.28.3 of the FIA CCR General Prescriptions 2009. If necessary only, telephones may be used, only outside of the vehicle, with the vehicle stopped.

#### 13.6. Reconnaissances

Reconnaissance of the route is totally forbidden. Possession of route notes or other informations different from those given by the Organization is forbidden. Penalty decision at Stewards' discretion.

The only official route is that set out in the Road-Book.

To help competitors, the Organizer will indicate intersections and features of the route by means of arrows and tapes. The Road-Book shall be, however, the only official document for the itinerary to be followed.

Service vehicles and other automobiles are allowed to enter the Service Park only if they are identified with service plate affixed on the vehicle as instructed by the organizer. If a service vehicle entered to service area, authorized to remain in area till the race car take part in rally. If a car withdrawed from rally, the service wehicles and race cars must be leave the service area till the end of relevant day. The maximum speed allowed in the Service Area is 30 km/h.

#### 14.3. OPERATION OF THE SERVICE AREAS

For safety reasons and the proper functioning of the Service Areas, entry will be permitted only to service vehicles showing the Plates supplied by the Organization.

Tampering with or falsification of these plates will lead to disqualification of the team to which these service vehicles belong, on the decision of the Stewards.

Plates will be placed in a visible area of the front windscreen of the vehicle.

The maximum speed allowed in the service parks is 30 km/h

- 14.3.1 Towing, pushing (or any other means allowing a vehicle to move other than thought the normal an mechanical operation of its engine) is prohibited, unless it is in order to bring a vehicle into the road or to clear the track or to exit the parc fermé, in the latter case with a 15 minute penalty.
- 14.3.2 Throughout the rally, servicing of a competing car may be carried out only inservice parks. Repairs that may be carried out by a team using on-board equipment or equipment carried by another participant in the race are authorized along the whole route. Any other external servicing outside the authorized areas is forbidden and shall be penalized by EXCLUSION at the Stewards' discretion.
- 14.3.3 The event may be followed from the air after expressly authorized by the Organization Committee. The team must obtain also the necessary legal permits from the Hungarian Aeronautical Authority.
- 14.3.4 In all service zones for all competiting cars schould be used a protection sheet under the wehicles at least 5x4 meters. Soiling must not be remained on the site. All entrants must make sure that no contamination remains at the venue, these will be controlled by the marshals and the technical scrutineers!

The violation of these rules will be sanctioned by a penalty of 200 EUR/case.

#### 14.4. REFUELLING

#### 20. OTHER ANNOUNCEMENTS OF THE ORGANIZER

The On - Line GPS (SaWaTOS®) needs a permanent, stable 12V connecting. The crews have to check its perfect working during the whole route. The route taken by the crews will be checked at the finish of the Legs (or more often) by the organizing committee. The GPS and its competence will be controlled on the scrutineering.

The Road Book contains the GPS controlling signs. The prescribed track-line by the road book will be checked on the classification. Those who deviate from the route will receive 30 minutes penalty by missing or deviated GPS Controlling Signs which does not count into the Leg's limitation time.

\*Fixed penalty (Forfait penalty):\* crews, who "perfectly" cannot continue the Leg's route for whatsoever reason, allowed to enter her own power (working engine), in the parc fermé of the leg till in these regulation published time for publication of provisional results, or one of the forthcoming regroupping Station till in the roadbook published entry time of first car from regroupping station. These cars are allowed to continue the rallye considered the following penalties: selective crews without measured time aet the particular section's maximum allowed time +30 minutes per selective sections.  $\cdot$  30 minutes penalty per missing Control Zones, which are not in the Selective Section.

These "Forfait penalty" can be used only one time during one day (leg) of race.

The organiser will provide all entrants with new start numbers (3+1) and identification cards, which will only be valid at the HunGarian Baja event.

The location of the stickers are given by the diagram in the appendix of present regulation. The organiser will communicate the type of the advertisements in the form of a bulletin before the start of the administrative checks.

**Service Park:** repairing is only permitted in the Service area. There is a marked Refuelling Zone. The vehicles can be refuelled at the crew's only in the Refuelling Zone. Air assistance is forbidden between the start and finish of the Leg. Only cars with service boards can be in the Service Park. The Road Book contains the place of the Service Zones. In all service zones for all competiting cars schould be used a protection sheet under the wehicles at least 5x4 meters. Soiling must not be remained on the site. All entrants must make sure that no contamination remains at the venue, these will be controlled by the marshals and the technical scrutineers!

The violation of these rules will be sanctioned by a penalty of 200 EUR/case.

Please note that cars with service plates will only be allowed to enter the service zones. The crews have to put their Identifying Cards on the car, which they will get on the administrative check (photos!!!). The infrigement of these rules and the documents asked on the administrative check, the crews will not receive the permit for start.

Exceeding the maximum speed limit (30km/h) in the Service Area and the Refuelling Zones will be measured by the organiser, and it will be sanctioned with a fine and time penalty.

1km/h= 50 EUR + 10 seconds

In the case of changing in the supplementary regulation, the organizer will be send an official bulletin.

In all circumstances, drivers may only participate at the event under their own responsibility.

At the entire route of the event the national traffic rules must be respected.




