## **8. Fuel**

All type of fuel must follow Appendix J Art. 252.9. (Art. 57 of the FIA CCRSR).

Only commercially available fuel can be used, without adding any additives.

There are only in part petrol stations along the whole track of the **Baja Satu Mare 2021**, therefore refuelling can be done in the serviceparc area with the engine turned off. Having a min.4kg fire extinguisher and a plastic mat is mandatory! The entire refueling process in the service park is the sole responsibility of the team! Only fuel stations for SBS, moto, quad vehicles will be designated on the route, which is included in the road book.

- ) Homologation Form, valid Technical Passport
- ) All items of clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g. HANS devices, must be presented
- ) Technically corresponding and approved size fire extinguisher properly fitted in the car
- ) Warning triangle, medical kit. The new medical kit...etc. is not mandatory ( Art.CCRSR APPIII. 1. Medical kit, 2. Survival kit)

#### **Art. 10.3 Installation of the GPS Navigation and Safety Tracking System**

All vehicles must **only** be fitted with the GPS Navigation and Safety Tracking System provided by the Organiser. You can collect them just before the Administrative check, the associated installation package can be purchased or rented.

The instruction for the use of the Tracking System is in the Appendix 3. of these Supplementary Regulation.

Regarding to the COVID-19 epidemic, the Organizer makes the following provisions: According to the Government Decree 484/2020 (XI.10) on protection measures to be applied during an emergency, the Organizer does not allow the public to attend the event!

The Event will run behind 'Closed Gates'!

At the event, all participants are obliged to comply with the requirements of the Government Decree as well as the hygiene requirements and social distancing of 1.5 meters! At the Rally Office max.3 pairs of competitors are allowed at a time, the use of a mask - or a closed helmet - is mandatory!

The Organizer took into account the current government decree, in case of changes, the Organizer reserves the right to amend the event. "The event will be held in compliance with the current epidemiological regulations of the Romanian government."

##### **Art. 11.7.1 Availability of participants**

Participants who park their vehicles in the Parc Fermé upon passing the finish line, must remain available by phone (mobile) until the final classification have been posted.

#### **Art. 11.9 Electronic start procedure at the start of a Selective Section**

The start of the selective section is happening based on an electric clock and lamp, connected to a false start alert system.

When the car arrives at the start line, the front of the car should be positioned behind a stick placed by the marshal to define the exact start position. One minute before the start time, but not before the car has stopped in its exact position, the marshal shall remove the stick and the crew shall refer to the automatic countdown clock. Any subsequent change of the car's position until its start time is not permitted and will be reported to the Stewards.

#### **Art. 11.10 Service**

Using a min 5x4m protector groundsheet under the racing vehicles is mandatory. 1pc at least 4kg validated manual fire extinguisher is mandatory. Each service team has to ensure that after carrying out their activities on the site, they do not leave any pollutants. They will be checked by the scrutineers, and not complying will entail a 50.000HUF fine.

The Organizer calls the attention of the participants, that the Service Park is not guarded at night time!

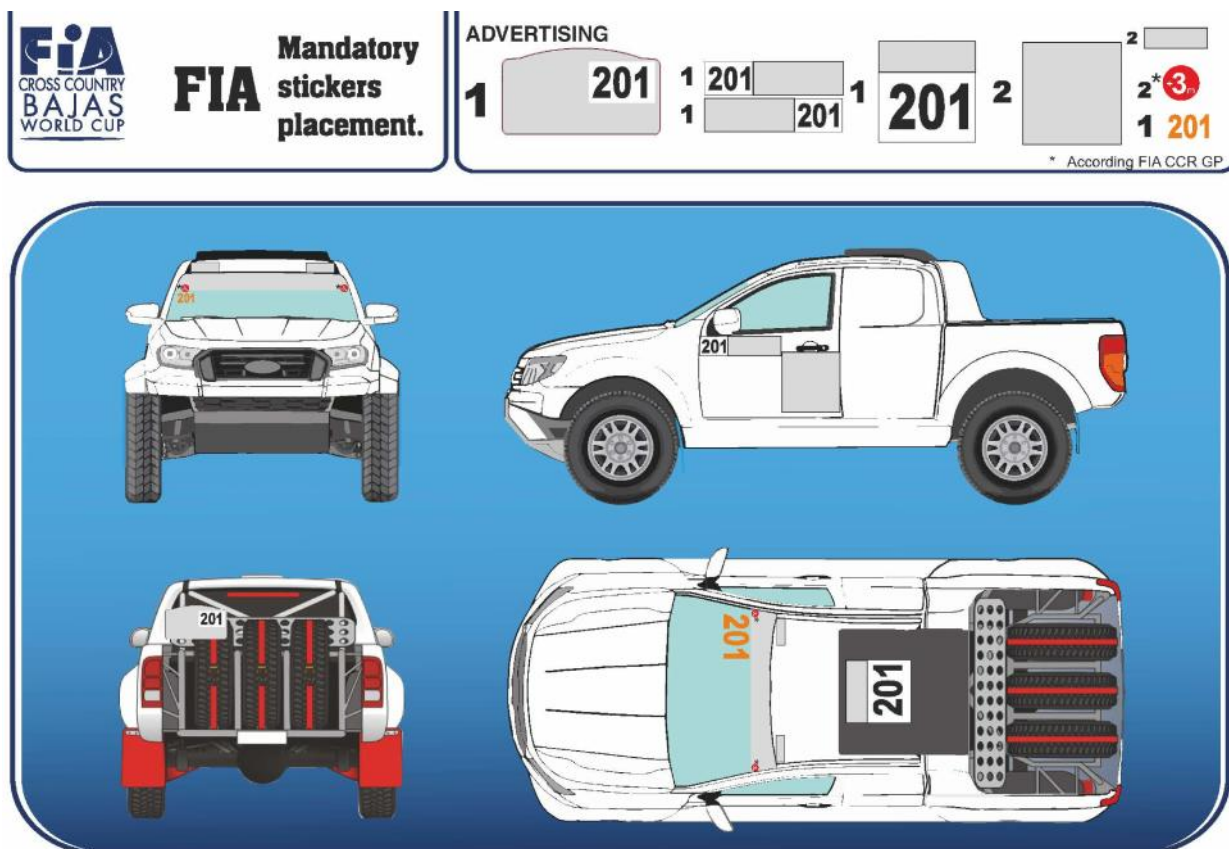

## Appendix 4 – Extracts from FIA ISC Appendix L relating to overalls, helmets and any other safety requirements

---

All competitors are reminded of Appendix L of the FIA International Sporting Code, in particular its Chapter III - Drivers' Equipment.

### **Helmets (Appendix L, Chapter III, Art. 1)**

All crews must wear crash helmets homologated to one of the following FIA standards:

- ┐ 8858-2002 or 8858-2010 (Technical List N°41),
- ┐ 8859-2015 (Technical List N°49),
- ┐ 8860-2004 or 8860-2010 (Technical List N°33), or
- ┐ 8860-2018 or 8860-2018-ABP (Technical List N°69)

### **Frontal Head Restraint (FHR, Appendix L, Chapter III, Art. 3)**

All crews must use FIA approved FHR systems homologated to FIA standard 8858.

Approved FHRs, anchorages and tethers are listed in Technical List N° 29.

See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.

### **Flame-resistant clothing (Appendix L, Chapter III, Art. 2)**

All drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard (Technical List N°27) or 8856-2018 (Technical List N° 74). Please pay special attention to the prescriptions of Art. 2 concerning embroidery and printing on flame-resistant clothing (manufacturer certificates etc.) **as well as concerning the correct wearing of the clothing elements! See also FIA Cross-Country Rally Sporting Regulations Article 48.1.**

### **Biometric Devices (Appendix L, Chapter III, Art. 2.1)**

Drivers may wear a device to collect biometric data during racing.

- ┐ If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.
- ┐ If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.

### **Wearing of jewellery (Appendix L, Chapter III, Art. 5)**

The wearing of jewellery in the form of body piercing or metal neck chains is prohibited during the competition and may therefore be checked before the start.

### **MEDICAL AND SURVIVAL KIT (Appendix III of the Cross-Country Rally Sporting Regulations)**

A sealed and valid Medical kit in accordance with the Specification for Cross Country Rallies and Bajas (Technical List n°83) must be placed inside the cockpit. The minimum weight must comply with Technical List n°83.

### **Appendix 7 Items at the organisers' discretion**

#### **1.TIME CARD PROVIDING/EXCHANGES**

Time cards will be issued before the Start of each Leg, which must be submitted to the marshalls at the Finish of each Leg. The time card must be filled up by the competitor as instructed by the judges.

Time card exchanging: at regrouping.

#### **2. LIMITED TIME DELAY**

Maximum delay between two TC is 30 minutes per Leg. Delay exceeding this limit will result in disqualification.

#### **3. FIXED PENALTY**

Competitors who got fixed penalties on the day of the race, can revert to the race- at regrouping areas and Parc-Fermé at the end of the day, until the first vehicle's planned time, or at evening Parc-Fermé, no later than 15 minutes before the publication of next day's start list.

The specified penalty can only be used once on race days.

On Friday, June 04, 2021, no competitor (s) who have not completed a selective stage may enter the Parc Fermé and continue the competition on Saturday, June 05, 2021.

On Saturday, June 05, 2021, the competitor must complete an evaluated selective stage in order to be evaluated in the competition.

#### **4.Park Fermé**

The washer-tarpaulin is mandatory!

#### **5. MAXIMUM SPEED**

FIA maximum speeds (130 km / h, 180 km / h) are monitored by the GPS system and punished by FT.

#### **4. CHALLENGE GROUP**

Regulation: TROB Regulation and sporting rules 2021.

Daily licence starters are required to present a **Sports Medical Check Certificate!**

**Evaluation:** depending of the number of the entrants!

Challenge group is competing at a certain average speed, performing orientation tasks. The reduced average speed for a specific stage will be determined by consultation between the Organizer and the Clerk of the Course. The competitor closest to the specified average speed (+/-) will be the winner of that stage. With the GPS navigation and safety tracking system, the average speed can be measured on different speed control points. At the end of the event, the Challenge Group's evaluation will be determined by taking into consideration the speed on the designated selective stages as well as any delays or early arrivals on the routes connecting the selective stages (etap).

In case of non-compliance with the rules, the Clerk of the Course decides on the further participation of the disciplined competitor on the basis of the Marshall's report, primarily based on the TROB Regulation and sporting rules 2021, but may also decide on immediate exclusion and initiate the revocation of the licence.

**CH category not performing SS1, SS3 and SS5.**

**Reconnaissance of the entire Baja Satu Mare 2021 route is forbidden!**
