#### 4.4. Entry fees

##### 4.4.1. Entry fees to be paid by the participants of the National Rallye Championship and participants out of the championship:

###### Entry fee with Organiser's advertisements:

for entrants with 4WD cars **HUF 180.000**, which contains 27 % VAT

Without Organiser's advertisement: **HUF 360.000**, which contains 27 % VAT

for entrants with 2WD cars **HUF 100.000**, which contains 27 % VAT

Without Organiser's advertisement: **HUF 200.000**, which contains 27 % VAT

##### 4.4.2. Fee of the GPS device

The RSB prescribes the use of the GPS device for the entrants of the 74th Mecsek Rallye. The use and the operation is obligatory for the full duration both of the reconnaissance and the race.

The rental fee of the device (**HUF 10000**, which contains VAT) has to be paid at the receipt of the roadbook for the operator of the system. By signing the entry form the entrants give their contribution to the operator of the GPS system to pass over data to the organiser, the management of the event, and to the RSB.

#### 4.5 Terms of payment

The entry applications will only be accepted if accompanied by a document certifying the payment of the total entry fee or its transfer is performed, and these documents are submitted to the Close of entries or at the issuing of the roadbook the latest. ### 6. ADVERTISING AND IDENTIFICATION

The Organizers' of the events can prescribe apart from the start number and the start number advertisements positioned directly related to it, four additional advertisements for the participants, on both doors, directly under the start number panel and under the related start number advertisement surface, a 20 cm height and 67 cm wide place have to be ensured on the racing cars. The Organizers' advertisements have to be fit in this surface. The place, size and the subject of the above mentioned advertisements have to be published in an official amendment till the issuing of the roadbook in a form stated in the Supplementary Regulations. Otherwise the competitor can refuse the Organizers' advertisements for free.

In case of the refusal any of the Organisers' advertisements an additional entry fee has to be paid, during the event for the lack of them a fine can be imposed (max. the amount of the entry fee).

***Not appropriate sticking and/or cutting, cutting around of the Organizers' advertisements are considered as the refusal of the Organisers' advertisements. The Organisers' advertisements have to be worn also on the official cars of the event.***

If the Supplementary Regulations, the official information leaflets, bulletins states, the so called „front windscreen stripe” of the entered race cars is considered as an advertising surface can be used by RSB.

The rallye plate and the advertisements (MNASZ or Organisers') belonging to the start numbers are not considered as advertising tools and they can not be refused.

The start numbers and the advertisements must not be longer the body of the car. For the advertisements positioned on the windscreens the regulations of FIA and MNASZ have to be observed.

## 7. TYRES

Tyres specified for use during the Rally: in compliance with FIA Prescriptions.

Tyres can be used on reconnaissance: Based on the general rules of Hungarian Highway Code.

The organiser permits the manual cutting of the tyres at the service park.

## 8. FUEL

Furthermore to fuels allowed by FIA, Fuel E85 (standard MSZ CWA 15293) is also accepted in all classes of the Hungarian Rally Championship, on the stipulation that this fuel is commercially available but can not be mixed with gasoline and other additives.

## 9. RECONNAISSANCE

### 9.1 Registration procedure

Before the reconnaissance, the competitors are obliged to fill in the registration form (see Appendix 5 of present Supplementary Regulations, plate number and privacy statement) and to submit it at the issuing of the roadbook at the latest. After filling in the statement and the collation of the data, the crew get their identification card which must be supplied with 1-1 pc of ID photo.

The identification card has to be in the racing car during the event, and it has to be well-visible from outside in the right rear window.

In case of change of co-driver after the issuing of the roadbook, a new identification card will be issued for the competitors on the administrative checks.

Every crew will receive an identification sticker from organizer supplied with an identification number, which must be affixed in right upper part of the windscreen during reconnaissance at all times. Missing sticker or sticker not had been stuck will mean failure of the reconnaissance prescriptions. In the case, that sticker is damaged or in the case of the changing of the recce car, the crew needs to ask for new sticker

**During the reconnaissance the foreign entrants have to take their licence with them and in case of request from the inspectors, marshals in the recce', it has to be shown.**

During the reconnaissance only those competitors can be present at the recce car who are entered to the event.

### 9.2 Specific / national prescriptions – speed limits on SS

We emphasize to the entered competitors, that reconnaissance is not a practice. The relevant parts of the Highway Code of Hungary must be strictly adhered to and the safety and rights of other road users must be respected. In forestry roads, the speed limits have to be observed according to the plates. In case of lack of plates, the maximal allowed speed in non-public roads is 50 km/h.

Speeding during reconnaissance and the race will incur a fine applied by the chairman of the Stewards according to the following:

in case of exceeding the speed limit, per km/h:

up to 50%:	HUF 1.000 per km/h
above 50%:	HUF 2.000 per km/h

The amount of this fine will be unaltered by any fine imposed by the Police or forestry police. Other infringements or excessive speeding during reconnaissance may be referred to the Stewards.

During the recce, only street car can be used. It is forbidden to make reconnaissance with the competing car which is entered into the competition.

**Restrictions for the recce cars:**

- the exhaust shall be a series production exhaust with a maximum noise level within the permitted Hungarian noise level
- the safety roll bar is permitted in accordance with Art. 253.8.1 – 8.34 Appendix J
- 2 additional road-homologated headlamps are authorized
- the crew may use a "light" intercommunication system (without helmets)

Organizer will perform speed check during the duration of the reconnaissance with validated radar device.

**9.3 Mounting of the speed control equipment**

The RSB prescribes the use of the GPS device for the recce cars. The recce cars must have „cigarette lighter” connection.

### 12.1 Ceremonial start and start procedure

The start of the cars will be performed according to ascendant start order, 1 per minute.

The access of the ceremonial start and finish podium will be detailed at the roadbook.

For late or early arrival, fine will be imposed, HUF 10.000 per minute.

**During the start ceremony the wearing the overall is obligatory for the entrants.**

### 12.1 Start order

At the events of the Championships, the start numbers will be issued from 1, according to the following order:

1st group - FIA priority competitors

2nd group - national priority competitors

3rd group - all the other competitors from class 2-15

4th group – all the other competitors

### 12.2 Procedure of the finish ceremony

**Location:** Pécs, Széchenyi square

**Organisation:** the finish podium will be installed in the regrouping area between TC 7D and TC 7E. The competitors has to arrive to the "Regrouping in" to their own ideal time. After the registration of the time card, they have to be positioned in the territory of the Regrouping according to the directions of the Marshals.

During the Finish Ceremony, the competitors can go to the podium in the following order: overall 3-2-1. After this the Finish Ceremony will be continued according to the arrival order.

### 12.5 Other special procedures/activities including the promotional activity of the Organizer

The Organizer of 47TH MECSEK RALLYE has exclusive rights for representing assets (e.g. rights to catering, commercial or advertising). Pécsi Sport Nonprofit Zrt. and Pécsi Fesztiválszervező Nonprofit Kft. entitled for the exclusive rights to the above mentioned.

## **12.7 Procedures to be performed in case of an accidents**

If an accident takes place on a site where spectators have been or might have been present the driver of the car is obliged to stop immediately and assess carefully whether anyone is injured or involved in a dangerous situation. If so, the driver is obliged to give them help.

If someone becomes injured, the chief marshal has to be informed and the traces must be preserved as far as possible.

The competitor shall not continue the rally and is allowed to leave the site only with the permission of the policeman on duty.

If this rule is not observed, the Meeting of the Stewards can impose a fine on the responsible competitors, up to exclusion.

### **Accident and safety requirements**

- 1) All entrants must thoroughly know the General Regulations of FIA Rally Competitions, Art. 40 The safety of the competitors.
- 2) If a red "SOS" sign is set the competitor must stop and provide any necessary help. The competitor is obliged to help the injured and ensure that the security service be alarmed as soon as possible.
- 3) The first competitors arriving on the site of the accident have to stop and inform the next vehicle about all the details.
- 4) The next vehicle must give the following information at the next radio point which can be the last stop as well.
- 5) The next car must submit the following information on the next radio point which can be the last station as well:
  - Start number of the competitors involved
  - Number of competitors injured and how they were injured
  - Number of competitors or spectators got stuck or are out of their cars
  - Location of the accident, e.g. the next sign in the itinerary or kilometre data
  - Any other basic information, e.g. fire, water...
- 6) All the following cars have to stop if the red "SOS" sign is set.
- 7) Every competitor stopping at the special stage must set the red triangle indicating getting stuck, at least 50 m before the place of stopping, even if the road remained free.
- 8) First aid phone number of the rally: +36-30/220-3132 (Secretariat)
- 9) If a competitor stops competing in the rally, he/she is obliged to inform:

- 10) All competitors retiring from the event have to hand in their time card at the nearest control point as soon as possible.

**12.8** “Doughnutting” with the car after the finish podium, at the territory of the Parc Ferme and all of the areas of the event is strictly forbidden by the Organizer.

**12.9** Additional road books will be available to buy for the entrants. The cost of additional road books is 5000 HUF (incl. VAT) payable together with the entry fee. The additional roadbooks can be obtained together with the invoice at a given time.

**12.10 The team leader pass holders can obtain the team “Team leader” plate at the Administrative checks.** In this case the Team leader ID and the entrant’s licence have to be shown. The posts at time control special stages can be approached by holding a “Team Leader” plate. The plates are to be placed in the top right corner of the front windscreen. Organizer ensures parking spaces for team directors in the designated areas of Service Parks.

**12.11** The Organizer allows the use of light and heat protective foils on glass surfaces of the racing cars during the entire event. The use of silver-plated or tinted foils on the side and rear windscreen and on the glass roof-hatch is possible, observing the following conditions:

**12.16** The Organizer of the 47th MECSEK RALLYE hereby and in other ways accessible and visible for anybody, informs everyone taking part in the event in any capacity on their own responsibility, and the Organizer and its colleagues refuse to take any liability for any potential damage, injuries to the participants.

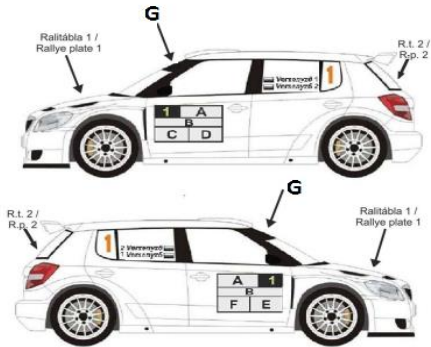
