In competition of Rallye2 type of Suzuki Swift (MAB 35S) with national homologous card can enter to N class if satisfies the other regulations of N class (and have no FIA homologous card).

Cars with expired A or N homologous card can also enter to the competition, if satisfies their own homologous card, rule in effect by the FIA and national rules in N and A group, have valid technical passport OR have FIA Technical Passport.

Cars with fuel diesel will start at real (without multiplier) class by displacement.

Parts can be used only if they can be found on extension of homologous card of VO, VF, VP, ET, ES, ER in competitions of Rally2 group A and N.

Cars in P group can race in F group and the appropriate F class, if the satisfies all technical regulation in P class and have homologous card issued by the national regulations and have valid technical passport in P group issued by the MNASZ.

Cars with fuel diesel will start at real (without multiplier) class 1 or 2 by displacement, but must be appropriate to the regulation of minimum weight of corrected cylinder capacity and maximum wheel width.

Tires can be used by the appendix.

All participants of Veszprém Rallye 2013 are compulsory to use GPS monitoring system, the use and operation of the equipment is compulsory during the reconnaissance and the whole competition.

The rental fee of the equipment (10.000 HUF which includes VAT) must be paid to the system operator at rood book issuing. The competitors contribute to the GPS system operator that data can be given to the Rally Headquarter and MNASZ Rally Sport Committee with his/her signature on the entry form.

#### 6. ADVERTISING AND IDENTIFICATION

The organizer may require competitors to carry 4 optional advertising except the advertising which is placed beside of the competing numbers. Competitors must reserve space for it with dimension 20 cm high and 67 cm width on the both front doors of the competing car.

Size, placement, name of these advertisings must be published in the supplementary regulations or other way, which is described in the supplementary regulations till the road book issuing. In the other case competitor may refuse these advertisings without any fines.

If a competitor declines this advertising he is compulsory to pay increased entry fee. If it is found at any time during the rally that advertising is missing from the rally car a cash penalty in an amount of the entry fee will be imposed.

Any absurdly affixed advertisement or mutilated advertisement or trimmed away means the advertisement was rejected. The Organizer optional advertising must be worn on the competing car as well.

If the Supplementary regulations, Official Information, Bulletins decree about is, than the entered car's first windshield stripe surface considered advertising place for the Hungarian Rally Committee.

Any advertising (even MNASZ or organizer), which is part of the rally plate, competing number and the first windshield stripe is not consider as advertisement.

FIA and MNASZ prescriptions are valid for any advertisements which are placed on the competing car windows.

#### 7. TYRES

During rally - according FIA prescriptions.

During reconnaissance – according Hungarian traffic laws.

#### 8. FUEL

Fuel E85 (standard MSZ CWA 15293) – except of FIA fuel - is also accepted in some classes of the Hungarian Rally Championship. This fuel is commercially available but not be mixed with gasoline and other additives.

#### 9. RECONNAISSANCE

#### 9.1. Procedure for registration

Before reconnaissance crews must fill in registration form (Appendix 10 of this Supplementary Regulation, plate number, privacy policy) and submit it the latest at the date of the road book issuing.

Competitors will get also identification card and they must submit 1-1 pc of photos. This card must be in the competing car during whole reconnaissance. The crew must show this card every time on the Marshals demand.

If there is a new co-driver after road book issuing the competitor team receive a new identification card at administrative check.

Every crew will receive an identification sticker from organizer, which must be affixed in right upper part of the windscreen during reconnaissance at all times. Missing sticker will mean failure of the reconnaissance prescriptions. In the case, that sticker is damaged or in the case of the changing of the recce car, the crew needs to ask for new sticker.

Competitors must carry license during reconnaissance and show it (if they ask for it) to the Marshals.

#### 9.2. Specific / national prescriptions - speed limits on SS

We emphasize to the entered competitors, that reconnaissance is not practice. All road traffic laws of the Hungary must be strictly adhered to and the safety and rights of other road users must be respected. Speeding during reconnaissance will incur a fine applied by the Stewards as detailed in the supplementary regulations.

up to 50%: 1.000,- HUF km/hour over 50%: 2.000,- HUF km/hour

The amount of this fine will be unaltered by any fine imposed by the Police. Other infringements or excessive speeding during reconnaissance may be referred to the Stewards.

It is forbidden to make reconnaissance with the competing car which is entered into the competition.

#### Prescriptions for the recce cars:

- the exhaust shall be a series production exhaust with a maximum noise level within the permitted Hungarian noise level
- the safety roll bar is permitted in accordance with Art. 253.8.1 8.34 Appendix J
- 2 additional road-homologated headlamps are authorized
- the crew may use a "light" intercommunication system (without helmets)

Organizer will check the speed limit during recce with Stalker PRO ill. Kustom Pro Lite (serial no.: 200-2072-00) type certified radar.

#### 12.6 Special regulations includes organizer's promotional activity

At the event of Veszprém Rallye utilization of property rights (for example: activity of restaurant, commercial, advertising) belongs to the director of the event.

Laroco MSE entitled to provision of these rights

#### 12.6.1. Procedure in the case of the accident

If the accident happened on the place with spectators, the driver is compulsory immediately stop and be sure if anybody was not injured or if anybody get into the risk. If yes, the drivers are compulsory to help. In the case, that any person obtains injury, the SS Chief must be informed and take care about foot marks. The crew may leave the place of the accident only with Police approval. Any infringement of this regulation will be penalized by the Stewards, penalty may go as far as exclusion.

#### Requirements in the case of accident and safety requirements

- 1) All participants must thoroughly know Art. 36 of the FIA Prescriptions.
- 2) When a red "SOS" sign is displayed, the crews is mandatory immediately to stop to render assistance. The crews are compulsory to help to injured persons and make sure that safety services are mobilized as soon as possible.
- 3) The first competing car to arrive at the scene of an accident must stop and inform the next car of all the details.
- 4) The next car must take the following information to the next radio point (it can be also SS finish) and submit the following information:
  - Competing number of the involved crew
  - Number of injured persons members of crew or spectators and sort of their injury
  - If any crew member or spectator is trapped in or outside the car
  - Location of the accident, i.e. the closest road book junction or kilometre post
  - Any other vital information, i.e. fire, water.
- 5) The following cars must stop if the red "SOS" is displayed.
- 6) All competitors stopped in the SS must place their red triangle at least 50 m before where the car is stopped even if the car is clear of the road.
- 7) First aid of the organizer: +36-20/515-40-74 (Rally HQ)
- 8) In the case of the retirement, the crew must report it to:

Organizer: +36-20/515-40-74 (Rally HQ)

Competitors' relation officer: Rádli József: +36 30/944 2323

- 9) Competitor, which retired from the rally, are compulsory submit their time cards in the next TC as soon as possible.
- **12.6.2.** Organizer forbid to the crews to perform doughnuts with car after the finish and in the Parc fermé area!

- 12.6.3. Organizer allows buying road books in addition by competitors. The price is 5 000.- Ft (including tax). This price must be send together with the entry fee.
- 12.6.4. Chief of the teams (according "Chief team pass" or competitor license) could assume "Csapatvezető" table during administrative check. Everybody must show his/her pass or license. Only with this table is entry to the TC and SS controls allowed. This table must be affixed in right upper part of the windscreen. Organizer will reserve restricted area in the service park for these cars..
- 12.6.5. Organizer permits to use tinted films on competing car windows during whole rally. Colour or silver films are permitted on both side windows and on the rear and sliding sunroof upon

The driver must be recognizable from the outside through the film gap cutting.

- 12.6.6. A Damages on the rally cars caused by the impact with wild animals are excluded according Civil Code from 1959 year, No.: 345.
- 12.6.7. Organizers of the Veszprém Rallye 2013 retain the right for edition of various publications (printed or electronic). Any publication can NOT be made without written permission from Laroco Motorsport Egyesület.
- 12.6.8. Laroco Motorsport Egyesület will decide about utilization of the property rights (commercial, hostess, advertising ...) on Veszprém Rally 2013.
- 12.6.9. Media accreditations will be run according RSB and SAMS rules during Veszprém Rally 2013.
- 12.6.10. Organizer of the Veszprém Rally 2013 informs by this way, that the organizer is not responsible for any claims which occur to the participants of the rally. Everybody is responsible for himself.

During reconnaissance authorized passage 4 time / SS.

During reconnaissance competitors must stop at marshals at start and stop places of SS. Failure of this will be considered as violation of the reconnaissance rules.

#### 2. Specials / National regulations

Restriction of direction and number of visits

Direction during reconnaissance only by the itiner

Consequences of violation of the rule during reconnaissance will be a penalty by the director.

During reconnaissance the Hungarian regulation of transport must be followed as well as restrictions of private area roads.

During reconnaissance for entered competitors allowed passing each SS 4 times

Passes will be checked at start and finish by Marshals. Stopping is a MUST at the sign posted place and competitors must give the "reconnaissance card" to Marshals to sign.

During reconnaissance on SS race cars must stay on the marked trail which is in the itiner and it is forbidden to turn around.

SS during reconnaissance is not unsealed road, so these times other road users also can be expected – especially forest and agricultural machinery.

Competitors who do not comply with regulations of reconnaissance which is in Supplementary regulations – based on report of the Organizer, Stewards can punish from fine to exclusion and must inform RSB.

Cash penalty can be up to 250.000.- HUF

Competitors who do not comply with regulations of reconnaissance which is in Supplementary regulations – can be fined with time penalty by the Stewards based on report of the Organizer, in that case cash penalty is not possible.

During reconnaissance or during reconnaissance time in official rally rout competitors will be excluded if commit demonstrably traffic low violate OR accident OR damage to property. Entry fee will not given back, RSB must be informed.

Reconnaissance rules can be monitored also by Members of RSB independently from Organizer, who does not follow the rules, can be fined by RSB.

Penalties may be based on Inspectors of the forbidden reconnaissance by the Organizer. Inspectors:

- Members Of Organizing Committee;
- Colleagues of Laroco MSE;
- Members of Hunters Committee (territorial competent)

#### 3. Recording equipment installation

Use of recording equipment is compulsory in cars during reconnaissance.

#### 4. Rules for tires during reconnaissance

Tires types will be adjusted by the director of the event.

- Tires for winter or with sign M+S for vehicular use cannot be used during the reconnaissance!
- Gravel racing tires cannot be used (not even with "E" sign)!
- Summer tires with cut pattern for vehicular use cannot be used during the reconnaissance!



Service cars which entered the service park, can leave it anytime but **re-entry is forbidden – to the same service park.** 

Service cars may stay in the service park during the night. Organizer will establish the guard, but organizer will not have material responsibility for the things left in the cars.

Special parking for trailers will be established next to service park on grassland

#### **Regulation for "TEAMLEADER VEHICLE"**

Cars with stickers "CSAPATVEZETŐ" entitled to enter to the parking place which is close to the Service Park, and enter to the parking place next to the race track at the prepared closed public roads during approaches the SS.

Cars with stickers "CSAPATVEZETŐ" can NOT enter to the Service Park. Violation of this rule will be penalized by the steward with cash penalty up to 300.000,- HUF.

#### Regulation for "auxiliary vehicle": will not be issued

#### Other regulations of Service Park and services:

At service areas only for competitors with gold license can stay only authorized competitors' cars

It is forbidden (even temporarily) to go in or stay on street in places at technical passport, administrative check, road book issuing.

Violation of this rule will be reported by the Organizer and will be penalized by the steward with cash penalty up to 100.000,- HUF.

All service activities on public roads in Eger are **strictly prohibited** between 12-14.07.2013.

This regulation will be monitored by the Organizer, the Police and public land Officers

Any breach of these regulations will be reported to the stewards, who may impose a penalty as in Articles 152 and 153 of the International Sporting Code.

Only team cars with service sticker on it can stay at the total area of the service park and the designated service are according to competition numbers.

It is prohibited any commercial activities at the designated service areas. Vehicles with commercial, promotion and/or any other activity can stay only at permitted and agreed places by the Organizer.

Promotional activities for teams inside their service places can be performed for free.

Commercial activities, extra cars and request of bigger service place possibly only in a business agreement with the Organizer.

#### **APPENDIX 6: INSURANCE INFORMATION**

Compulsory car insurance: 10.800, - Ft, the fee must be paid at administrative check to a member presented by the Insurance company (see the 5<sup>th</sup> point of this Supplementary Regulation).

The insurance is to cover damages caused by competitors for third party on closed racetrack.

Competitors' damages caused by another competitor are not covered by the insurance.

Upper limit of the compensation: 10.000.000 HUF / damage, 25.000.000 HUF / event.
