 * In accordance with Article 11.6.2 and 11.16.3 of the International Sporting Code, judges of fact will have the following remit: during the running of the competition, describe in the Article 6.5 of the 2025 World Rallycross Championship Sporting Regulations, as well as, in their opinion, of any other dangerous and/or unsportsmanlike behaviour.

5. PROTESTS, PETITION OF REVIEW AND APPEALS

The protest or petition of review deposit is €2,000. The international appeal deposit (FIA) is €6,000 for World RX and €3,000 for Euro RX. Fee for the right of review deposit is € 2,000, (according to Art. 14.4.3 of the 2025 FIA International Sporting Code).

All protests must be lodged in accordance with the Code. All protests must be made in writing and handed to the chair of the panel of the Stewards. In the absence of the chair of the panel of the Stewards, such protests shall be delivered to one of the other Stewards, or in their absence, to the Race Director or assistant if such exists, or the Clerk of the Course or assistant if such exists., together with the required protest deposit or the prove to the payment of such deposit to FIA.







Competitors have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.

6. INSURANCE

In compliance with the legal prescriptions, the Organiser has contracted one or several insurance(s) guaranteeing the following risk(s):

- Third Party Civil Liability with a value of EUR 10 million minimum for any occurrence and (additional details).
- Public Liability EUR 10,000,000 Any one occurrence
- Products Liability EUR 10,000,000 Any one occurrence and in the aggregate in the Period of Insurance
- Pollution EUR 10,000,000 Any one occurrence and in the aggregate in the Period of Insurance

7. FINISH

Should the end-of-race signal be inadvertently delayed, the final classification will be established according to the positions considered at the moment of the prescribed race length
