According to the FIA International Sporting Code, foreign competitors/drivers must have their ASN's permission, which should be attached to the entry form (ASN's stamp on the entry, or the ASN's written permission to take part in the competition, or the licences copies with the described permissions in them)

In addition to the completed application, it is necessary to send scan copies of licenses of competitor and drivers, scan copies of FIA technical passports (all pages, please!), scan copies of FIA homologation form for T2 category, scan copies of any other documents, at the Organizer's request related to Administrative checks.

There are only in part petrol stations along the whole track of the **Kalo Race**, therefore refuelling can be done in the service park area with the engine turned off. Having a min.4kg fire extinguisher and a plastic mat is mandatory! The entire refueling process in the service park is the sole responsibility of the team!

The Event will run behind 'Closed Gates'!

At the event, all participants are obliged to comply with the requirements of the Government Decree as well as the hygiene requirements and social distancing of 1.5 meters! At the Rally Office max.3 pairs of competitors are allowed at a time, the use of a mask - or a closed helmet - is mandatory!

The Organizer took into account the current government decree, in case of changes, the Organizer reserves the right to amend the event.

Art. 11.9 Electronic start procedure at the start of a Selective Section

The start of the selective section is happening based on an electric clock and lamp, connected to a false start alert system

When the car arrives at the start line, the front of the car should be positioned behind a stick placed by the marshal to define the exact start position. One minute before the start time, but not before the car has stopped in its exact position, the marshal shall remove the stick and the crew shall refer to the automatic countdown clock. Any subsequent change of the car's position until its start time is not permitted and will be reported to the Stewards.

Art. 11.10 Service

Using a min 5x4m protector grounsheet under the racing vehicles is mandatory. 1pc at least 4kg walidated manual fire extinguisher is mandatory. Each service team has to ensure that after carrying out their activities on the site, they do not leave any pollutants. They will be checked by the scrutineers, and not complying will entail a 50.000 HUF fine.

The Organizer calls the attention of the participants, that the Service Park is not guarded at night time!



Appendix 4 – Extracts from FIA ISC Appendix L relating to overalls, helmets and any other safety requirements

All competitors are reminded of Appendix L of the FIA International Sporting Code, in particular its Chapter III - Drivers' Equipment.

Helmets (Appendix L, Chapter III, Art. 1)

All crews must wear crash helmets homologated to one of the following FIA standards:

- 8858-2002 or 8858-2010 (Technical List N°41),
- 8859-2015 (Technical List N°49).
- 8860-2004 or 8860-2010 (Technical List N°33), or
- 8860-2018 or 8860-2018-ABP (Technical List N°69)

Frontal Head Restraint (FHR, Appendix L, Chapter III, Art. 3)

All crews must use FIA approved FHR systems homologated to FIA standard 8858.

Approved FHRs, anchorages and tethers are listed in Technical List N° 29.

See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.

Flame-resistant clothing (Appendix L, Chapter III, Art. 2)

All drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard (Technical List N°27) or 8856-2018 (Technical List N°74). Please pay special attention to the prescriptions of Art. 2 concerning embroidery and printing on flame-resistant clothing (manufacturer certificates etc.) <u>as well as concerning the correct wearing of the clothing elements! See also FIA Cross-Country Rally Sporting Regulations Article 48.1.</u>

Biometric Devices (Appendix L, Chapter III, Art. 2.1)

Drivers may wear a device to collect biometric data during racing.

- If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.
- If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.

Wearing of jewellery (Appendix L, Chapter III, Art. 5)

The wearing of jewellery in the form of body piercing or metal neck chains is prohibited during the competition and may therefore be checked before the start.

MEDICAL AND SURVIVAL KIT (Appendix III of the Cross-County Rally Sporting Regulations)

A sealed and valid Medical kit in accordance with the Specification for Cross Country Rallies and Bajas (Technical List n°83) must be placed inside the cockpit. The minimum weight must comply with Technical List n°83.



General operating principle of GPS measurements:

The GPS is an advanced positioning system for three-dimensional position determination, timing and velocity measurements can be carried out by land, sea or air. Accuracy is typically of the order of meters, but the environmental conditions can affect significantly. In the sky from the flat graund there are 7-25 satellites visible at the same time, of which for positioning at least three, for the height above sea level one additional satellite is necessary for determination. The GPS satellites are broadcasting at six frequencies. Each satellite broadcasts spread spectrum signal which may be "pseudo-random noise" called for.

The positioning is based on the theory of analytic geometric methods. The satellite positioning system is based on timing recycle distance measurement. Since we know the velocity of radio waves, and we know the date of issue and receipt of radio waves, can be determined based on the distance of the source of these. In the three-dimensional space knowing the exact measured distance from three known positions we are able to determine the position. Measuring the distance with other satellites we are able to improve this value.

Cause A significant distortion in the system can be causd by the effect of atmospheric to the radio waves. At the description of the calculations we assumed that to simply calculate with the distance = rate x time formula. This is true, but that the speed of radio waves are only constant in the vacuum pressure.

Evaluation of data

The evaluation of uploaded data can be determined inf two different ways.

Initial assessment of the competition supervision interface, real time data available online. This means the data that the device has been uploaded to the central database and downloaded online, analyzed by the supervisory program. The yet uploaded, or not yet analyzed data will be carried over in the subsequent analysis. Not uploaded data case occurs when the device is




in the absence of strenght of GSM signal, and can not upload data to the central database. In the case where the data is available online in the database, but local network is busy or the downloads has interrupted due to bad network relationship, then the analysis of loss data only partially can take place online.

Alternate method is retrospective data analysis. In this case, the data collected what has been received by a specified time interval sets the database to a file, and the data can be evaluated from point to point.

Vehicle to Vehicle Alarm (VTVA) function

The device has a frequency of 433 MHz using radio module, which is broadcasting the data of an encoded in advance "bagpipe" and SOS functions corresponding sets of data, for the tools staying in range. The range distance can be greatly affected by ambient atmospheric conditions and terrain. The device has adjustable transmission power. This value is not possible adjustable during the race. Currently, the vehicle to vehicle alarm system has two functions:

- "Toot" function, which indicates the overtaking intent of a VTVA equipped car up to 100m distance. Pressing the SOS button, placed in the box, a red LED indicates the start, which lasts for 5 seconds. In the event that the other device receives the sent signal, then this confirms to the sending device and the server uploads the signal, and at the same time, in the overtaked vehicle's SOS panel's LED will lit blue with a beep sound (continuous), and in the overtaker's vehicle the LED color changes from red to blue light, no beep sound here. The indicator remains on the overtaked's vehicle for 10 seconds. Then, each signal is switched off until a next signal.
- Send SOS signal devices within range. This feature will be active if on the SOS panel, the SOS switch is turned on. Send the device continues the signal, until the SOS switch is turned on. In the case where a device receives the SOS signal, on the SOS panel the red and blue LED will blink, with a pulse (0.5 s) alarm signal, as long as is still within range. This feature requires a power supply operation.



Pic.No. 2.: **SOS Panel** Sizes: 95x48x67mm Weight: 120 g



- SOS panel, vehicle to vehicle alarm system antena placement: Previously purchased SOS




panel's red and black wires with the 2poled TMWS2T connector must be connected to the 5A fuse mating port (horizontal shoe positive, vertical shoe negative polarity), 15 poled connector's end has to be wired with the right B column. SOS panel should be placed on the dashbord in such a way that both the driver and the navigator can reach. The adhesive antenna supplied shall be affixed to the top right corner of the windshield horizontally, the end of the cable wired to the right-hand column B.

- Installing the device: The device received at the Administrative check must be connected to the previously purchased and installed SOS panel and vehicle to vehicle alarm system antenna. The device must be fixed in the right column B with 2 clamps so that the device does not move and the visibility ensured.



Pic.No 3. How to install 1.4




Pic. No 4. How to install 2.4

- At the end of the race the device should be returned to the colleagues, where the deposit will be repayed. In case if the device has any problem, until identifying the problem, the competitor is entitled to the deposit only after a corresponding deduction.

Appendix 6. Items at the organisers' discretion

1.TIME CARD PROVIDING/EXCHANGES

Time cards will be issued before the Start of each Leg, wich must be submitted to the marshalls at the Finish of each Leg. The time card must be filled up by the competitor as instructed by the judges. Time card exchanging: at regrouping.

2. LIMITED TIME DELAY

Maximum delay between two TC is 30 minutes per Leg. Delay exceeding this limit will result in disqualification.

3. FIXED PENALTY

Competitors who got fixed penalties on the day of the race, can revert to the race- at regrouping areas and Parc–Fermé at the end of the day, until the first vehicle's planned time, or at evening Parc-Fermé, no later than 15 minutes before the publication of next day's start list.

The specified penalty can only be used once on race days.

On Friday, Sept. 24, 2021, no competitor (s) who have not completed a selective stage may enter the Park Fermé and continue the competition on Saturday, Sept 25, 2021.

On Saturday, Sept 25, 2021, the competitor must complete an evaluated selective stage in order to be evaluated in the competition.

4. PARK FERMÉ RULES

The washer-tarpaulin is mandatory!

According to the basic notice 58.1, the area of the regrouping station qualifies as Park Fermé, therefore the Park Fermé rules apply in the area of regrouping stations.

5. MAXIMUM SPEED

FIA maximum speeds (130 km / h, 180 km / h) are monitored by the GPS system and punished by Steward's.

6. ELECTRONIC DATA STORAGE

The organizer draws attention to Articles 9.1.1 - 9.1.3 of the CCRSR. that all electronic and data storage devices not permitted in the notice are prohibited on board vehicles. Compliance with this is carried out by the technical inspectors and, in the event of a breach, by Steward's punish.

7. CHALLENGE GROUP

Regulation: TROB Regulation and sporting rules 2021.

Daily licence starters are required to present a **Sports Medical Check Certificate!**

Evaluation: depending of the number of the entrants!

Challenge group is competing at a certain average speed, performing orientation tasks. The reduced average speed for a specific stage will be determined by consultation between the Organizer and the Clerk of the Course. The competitor closest to the specified average speed (+/-) will be the winner of that stage. With the GPS navigation and safety tracking system, the average speed can be measured on different speed control points. At the end of the event, the Challenge Group's evaluation will be determined by taking into consideration the speed on the designated selective stages as well as any delays or early arrivals on the routes connecting the selective stages (etap).

In case of non-complience with the rules, the Clerk of the Course decides on the further participation of the disciplined competitor on the basis of the Marshall's report, primarily based on the TROB Regulation ans sporting rules 2021, but may also decide on immediate exclusion and initiate the revocation of the licence.

Reconnaissance of the entire Kalo Race route is forbidden!
