INTRODUCTION

GARZONE Racing Organization Promotion Ltd. will organise a Cross-Country Baja named "HunGarian Baja 2010" from 26th August to 29th August 2010.

The event will take place in accordance with the following regulations, to which all drivers and competitors signing the entry form will be bound:

- The FIA International Sporting Code (and its appendices)
- The 2010 FIA General Prescriptions applicable to the events counting towards the all FIA Cross-Country Rallies and the FIA International Cup for Cross-Country Bajas. (General Prescriptions)
- Present Supplementary Regulations and its appendices
- Official bulletins
- The traffic regulations of Hungary

HunGarian Baja is the 5th Round of the FIA International Cup for Cross-Country Bajas 2010.

Modifications, amendments and/or changes to these Supplementary Regulations will be announced only by numbered and dated bulletins (issued by the Organiser and approved by the FIA and National Automobilsport Federation of Hungary (MNASZ) up to the time of the first stewards meeting and thereafter by the stewards).

The Baja Cup is run in parallel with the event of the National Championships and with the event of the Open International Cup (T1,T2,T4,TH, Challenge, Open)

The event is the sixth event of the G4S National Cross-Country Championship of Hungary with coefficient two.

There will also be:

1. a National and Open International Event with separate regulations and starting after all FIA competitors; and
2. a Motorcycle/Quad European- and National Championship event with separate regulations and used same special stages but different time.

These Supplementary Regulations are published both in English and Hungarian.

In case of dispute concerning the interpretation of the regulations, only the English text will be binding.

For foreign competitors authorisation must be given by their ASN.
Each competitor should have a FIA Competition Licence Entrant/Competitors 2010.
Each Driver and Co-Driver should have a FIA Competition Licence 2010.

3.3 NUMBER OF ENTRIES AND CLASSES:

3.3.1 The maximum number of entrants will be 80 including all Priority Drivers.

If more than 80 entries are received, the Organiser has the right to decide which entries among the non-priority drivers will be accepted. Drivers with points for the FIA International Cup for Cross Country Bajas 2010 will be accepted.

3.3.2 Eligible Vehicles (cf. Art. 9.1 of FIA General Prescriptions 2010)

Vehicles entered in a class with less than 5 entrants will be competing only for the general classification and group classification.

3.3.3 Series production vehicles no longer homologated in Group T2 (Art. 9.2 FIA Cross Country General Prescriptions)

Series production vehicles, which are no longer homologated in Group T2, may be authorised to take part in Group T1 with a T2 safety and preparation level. Vehicles must fully respect Article 284 (Group T2).

3.3.4 4WD Vehicle with central or rear engine (Art. 9.3 FIA Cross Country General Prescriptions)

If a 4-wheel drive vehicle has an FIA technical passport drawn up before 31/12/2005, clearly indicating the position of the engine, it may be accepted even if it has engine situated to the rear of the middle of the wheelbase.

3.3.5 Eligibility of "Score" vehicle in Group T1 (Art. 9.4 FIA Cross Country General Prescriptions)

A vehicle complying with the "Score" regulations may be accepted in Group T1, on condition that the Competitor provides evidence that his vehicle is recognised by the "Score International" organisation. The vehicle must bear a safety inspection seal according to article GT2 of the regulations governed by this organisation.

In addition, the eligibility of the vehicle shall be subject to the final approval of the FIA Cross Country Technical Working Group.

3.3.6 Car Specifications for Priority Drivers (Art. 19.5 - 19.6 Cross Country Rally General Prescriptions)

For Priority 1 Drivers

- The cars must be in conformity with 2009 Appendix J, Art. 285, or with the 2010 Appendix J.
- Cars with Diesel Engines and driven by Priority 1 Drivers will have an air restrictor with a diameter 1 mm smaller than that prescribed in the 2009 Appendix J, Art. 285.
- Cars driven by Priority 1 drivers will have a gearbox with a maximum of 5 forward gears, or a restrictor that is 2 mm smaller than that prescribed in the 2009 Appendix J, Art. 285. For Priority 2 Drivers and Non-Priority Drivers

-The cars must be in conformity with the 2009 Appendix J, Art. 285, or with the 2010 Appendix J. Further, Petrol-Engined cars driven by Non-Priority Drivers may have an air restrictor with a diameter 1 mm greater than that prescribed in the 2009 Appendix J, Art. 285.

-Cars with Petrol Engines must be equipped with an air restrictor with a maximum internal diameter of:

- Priority 2 Drivers: 33 mm for cars with more than 2 valves per cylinder;
- Non-Priority Drivers: 34 mm for cars with more than 2 valves per cylinder.

3.3.7 Compulsory documents

The Group T2 vehicles must also have the FIA "T" group **original homologation papers**, and for everybody is mandatory the **Technical FIA Passport and the original homologations papers for concerned Roll Cages**, under pain of non-admission to the start. All cars of the Hungarian Competitors must compulsorily be provided with the MNASZ ATB Technical Passport.

3.3.8 Vehicles conformity

All the vehicles of **T1 and T2** Group must comply with the FIA Appendix "J" technical and safety rules 2009/2010 (Art. - 281 - 282 - 283 - 284 - 285 - 286).

3.3.9 Classes constitution

All the classes of every Group however will be constituted.

An entry will be considered invaild if it isn'n accompanied by the entry fee!

Crews entered for participation in the Hungarian Championship Event and paid entry fees in compliance with Supplementary Regulations of the National Championship event they have to pay less entry fees for participation in this event.

3.6 REFUNDS:

The entry fee will be refunded in full:

- to candidates whose entry has not been accepted (they will have registration fee reimbursed net of all relevant bank charges);
- in case of the Rally will not take place.

The organisers may refund 50% of the entry fee to those competitors who, for reasons of "force majeure" duly certified by their ASN and communicated to the Rally Office (Art. 2.2) with recorded-delivery letter, were unable to start the Rally.

4. INSURANCE

4.1 TRAFFIC INSURANCE:

Third party risk insurance (Traffic insurance) is compulsory for all crews taking part in the rally. All competitors must have a traffic insurance policy and present it at the administration checking. This insurance is valid both on road sections and special stages. Description of the organizer's insurance will be published before the administrative checking.

4.2 INSURANCE AMOUNTS:

The crew will get the supplement of the insurance on the Administrative Check.

The entry fee includes the insurance Premium for the following risks:

- Compulsory to third parties liability under current Hungarian regulations .
- The payment of those sums for which participants may become civilly liable as a result of accidents or fires caused by vehicles taking part in the event, up to a maximum of 5.000.000 HUF per accident or 25.000.000 HUF total amount.

4.3. OTHER PRESCRIPTIONS

In the event of an accident, the entrant, or its representative, must give written notification to the Clerk of the Course or the Secretary as soon as possible and within a maximum of 24 hours. This statement should set out the circumstances of the accident, damages, eventually blessed, as well as the names and addresses of witnesses. Competitors are reminded that only damage caused by the organizers and named drivers are covered by the Organization's insurance policy. Loss or injury that may be suffered by the drivers themselves or participating vehicles is EXCLUDED. Irrespective of this Third Parties insurance, entrants and drivers are free to take out the policies they deem fit on their own account and at their own discretion. Service vehicles, including those displaying the plates supplied by the Organization, shall under no circumstances be deemed participating vehicles. They are therefore not covered by the Organization's insurance policy and responsibility for them lies solely with their owners. In case of accident, competitors and drivers exempt the event organizers from any liability and waive any right to bring claims against them.

The insurance cover will come into effect from the administrative checking and scrutineering for the Event and end upon the expiry of one of the following time limits, whichever is the later:

- time limit for protests or appeals or the end of any hearing by the Stewards;
- end of the administrative checking and post-event scrutineering;
- end of the prize-giving

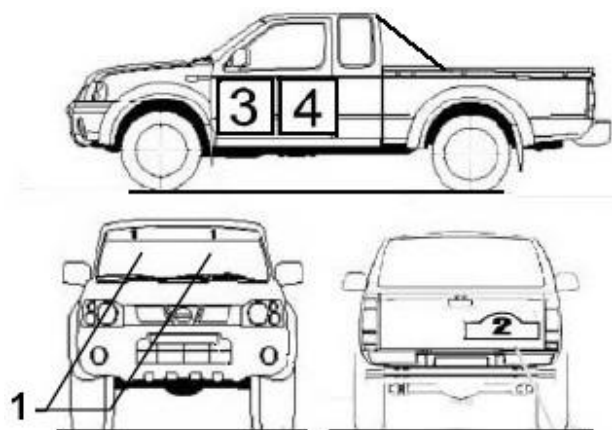

6. IDENTIFICATIONS

The Organiser will issue the "Rally" plates and the "Numbers" plates, according to Article 15.1 of the FIA CCR General Prescriptions 2010. These "Numbers" plates, the official "Rally" plate with the **race no.** (43 cm wide and 21,5 cm high) must be affixed on the rally car (details can be found in **Appendix 1**) before it is brought to Scrutineering and must be visible through the whole duration of the Baja, according to Articles 15.2, 15.3, 15.4 and 15.5 of the FIA CCR General Prescriptions 2010.

7. TYRES

7.1 In the Italian Baja 2010 for the T1 Priority Drivers with 4WD vehicles a single tyre pattern is authorised for each **FIA seeded driver** (according to the FIA list or if nominated as such race by race by the FIA in agreement with the organiser).

During Scrutineering, the pattern must be registered and the drivers must name and provide drawings of the type of tyre (Patterns and Dimensions).

a) Only these tyres may be used during the Rally.

b) A pattern is associated with each dimension and, if left tyres are different from right tyres, their patterns must be symmetrical.

These regulations apply exclusively to four-wheel drive cars.

7.2 Two-wheel drive T1 vehicles must use tyres from a tyre manufacturer's commercial catalogue.

7.3 Re-grooving of tyres is forbidden

9. TECHNICAL SCRUTINEERING, Sealing and Marking

The scheduled times for the convocation at the Administrative- and Technical Checks will be published in the Official Notice Board and in the website www.hungarianbaja.com and communicated at the every competitor by e-mail. This will be recorded by the time control. A cash penalty of 120 EUR will be imposed for any lateness of 10 minutes and 250 EUR for any lateness of 30 minutes to the scrutineering. Any car reporting to the scrutineering outside the prescribed time limits will be not allowed to start.

9.3 Helmets, head restraint (Hans System) and flame-resistant clothing's (Art. 12.5 FIA Cross Country General Prescriptions - App. L/Chap. III - App. J/283-11)

9.3.1 All drivers competing in the Baja must wear, during the Selective Sections, crash helmets which meet one of the standards listed in technical list n° 25 of Appendix J FIA, under pain of exclusion.

9.3.2 Wearing a **head restraint (Hans System)** approved by the FIA will be mandatory for all drivers and co-drivers during the Selective Sections, under pain of exclusion.

9.3.3 During the Selective Sections all drivers and co-drivers must wear overalls as well gloves (optional for co-drivers), a long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard, under pain of exclusion.

9.3.4 Drivers helmets, head restraint (Hans System) and flame-resistant clothing will be checked at the Scrutineering.

9.3.5 In the event of absence of a windscreen at the start of a leg, the wearing of a full face helmet with a visor or of motocross type goggles, or of an open face helmet with motocross type goggles shall be compulsory for all members of the crew, otherwise the vehicle shall not be admitted to the start of the leg. During legs, crews must always have motocross type goggles in the cockpit, to be used in case of windscreen breakage.

9.4. Parc Fermé after Scrutineering

After the technical scrutineering, the crews should place the car immediately on the Parc Fermé, located in the HQ!

10. SSS. SUPER SPECIAL STAGE

10.1 Super Special Stage description

On Friday 27 August will be a Super Special Stage inserted in the contest of a Super Special Stage Leg and located in Dabas zone, with a length of 7,00 km. This Super Special Stage will be run in the form of a Selective Section and will determine the Starting Order of the Leg 1, and the competitors must take part in it.

10.2 The finish time

Only for the Super Special Stage the finish times will be taken to 1/10th of a second to decide dead heats. Once the classification has been established and the starting positions for the Leg 1 have been determined, the 10ths of a second will be deleted and the times thus rounded down to the second immediately below.

10.3 Classification and Penalties

The classification of the Super Special Stage shall count for the classification of the Hungarian Baja 2010 as well as any road penalties of the Leg relating thereto. These penalties will be taken into account for the general classification of that Leg and applied the same day.

10.4 Maximum time of the Super Special Stage

In case of exceeding the maximum time previewed or not regular carrying out the Super Special Stage, the competitors will receive a fixed penalty of **30'** according to the successive art.12.16 that will be added in the classification of the Super Special Leg of the day. The competitors will be classified with the Super Special Stage Maximum Time previewed and in case of equal time the order of departure of the Leg 1 will be according to the increasing race numbers.

10.5 Reconnaissance

The reconnaissance of the Super Special Stages are forbidden in all the shapes.

11. START OF THE BAJA

11.1 PUBLICATION OF STARTING LISTS

According to Program. The list of crews eligible to take the start of the Baja and the starting list for the Super Special. Stage Leg will be posted on the Official Notice Board on Friday 27 August at 16.30.

The starting list for Leg 1 and Leg 2, established according to Art. 20.1, 20.2, 20.3 and 20.4 of the FIA CCR General Prescriptions 2010 will be published according to the Programme in these Regulations.

11.2 Parc Fermé before the official start

A Parc Fermé for the Start of the Super Special Stage Leg is where they are entered after the Scrutineering, to reach the Parc Fermé indicated above.

In the Start Parc Fermé crews should to be ready **15 minutes** before the individual ideal starting time.

11.3 Official start

The official start of the Baja will take place at Dabas, Friday 27 August 2010 at 16.30. (See the Programme and the Art. 1.8)

11.2 Briefing According to Program.

The road-book for that Leg and written briefing (if necessary) will be given to competitors at that day/morning (1 hour before the 1st competitor's start) according to program. To answer any query, the Crew's Relations Officers will be present at the place and time indicated on their working plan.

12. RUNNING OF THE EVENT

12.1 Road Sections and Selective Sections

The itinerary of the Baja is appointed by Road Sections with a scheduled time and roads open to traffic, and by Selective Sections in real time with roads closed to traffic.

12.2 Crew on board the vehicle

The full crew must be on board the vehicle throughout the entire duration of the Event, with the exception of the cases provided for in the supplementary regulations. If one member retires, or if a third party is admitted on board (unless this is to transport an injured person), the vehicle shall be excluded from the event.

12.3 Withdrawn

Drivers who have withdrawn before the end of the rally or have ended the leg following roads other than those allowed, must notify the Clerk of the Course of their withdrawal within one hour and must hand in their time card at the closest Control post. Competitors failing to abide to this prescription will be fined € 100,00.

12.4 Recovery of the drivers with a damaged car

The Organizers will assure the recovery of the drivers with a damaged car along the competition route, but will not be responsible for the recovery of the vehicles. Nevertheless, according to the local availability of personnel and means, the Organizers may facilitate the recovery of the vehicles. The costs involved by the vehicle's recovery will be borne by the competitor being assisted.

12.5 Use of telephones and VHF-type transmitters

(Art. 29.3 FIA CCR General Prescriptions 2010)

- a) All VHF, HF, CB transmitter/receiver or other electronic means of communication, other than GSM and/or satellite telephone, are forbidden on board the racing vehicles.
- b) For safety reasons the presence of a satellite telephone and/or a GSM phone (except PDAs or GSM phones featuring a GPS function or maps) on board vehicles is authorized.
- c) The number(s) must be given to the organizers during administrative checks.
Save as provided for in d) below, in no case may telephones be in 'on' mode during selective sections. Spot checks will be made.
- d) If necessary only, telephones may be used, only outside of the vehicle, with the vehicle stopped.
- e) These telephones may be used from within side the car, only on road sections and only by the co-driver.
- f) Any infringement will result in penalties which may go to exclusion.
- g) No permanent aerial, 'hands-free' kit, fixed installation or pre-wiring is authorised in the vehicle out of GPS and tracking system supplied by the organisers suppliers.
- h) No SMS, MMS, data transmission is allowed, and all equipment such as data cables, infrared links, Blue Tooth, Wi-Fi etc is banned.
- i) Only the telephone mode is allowed to be used. All infractions will result in exclusion from the race. Checks will be made throughout the rally.
- j) Any infringement will result in penalties which may go as far as exclusion.

12.6 OFFICIAL TIME:

Official time throughout the entire cross country baja will be that given by GPS time. It is possible to check the official cross country rally time in the rally HQ.

12.7 Road Book and navigation rules

The Competitors do not have to equip their car with GPS equipment, and the navigation rules do not to apply.

All competitors will receive the road book at the briefing, with the notes necessary to follow the route, which may be in some parts of the rally indicated on the spot by means of arrows or specific panels.

The Road Book must be compulsorily followed and the route indicated must be strictly observed under pain of a penalty, which can go as far as exclusion upon the decision of the Stewards.

12.8 Safety Tracking Equipment

It is compulsory for the competitors to equip their cars with the LOCHNER tracking + GMW system unit, for active monitoring of all participating vehicles.

The Tracking System incorporates both GPS Live tracking/recording and "vehicle-to vehicle technology. Commands and warnings from/to HQ and car-to-car are managed through the Main Box.

12.8.1 No competitor with a car without the tracking unit will be authorized to start.

12.8.2 The clerk of the course will use the competitors track monitored and recorded by the tracking system to check for eventual deviations and especially short cuts. These will be reported to the stewards who may apply sanctions mentioned in Art. 12.7

12.8.3 Any attempt to tamper with, to manipulate or to interfere with the tracking device fitted to the competing car or any device that fails to record a trace due to external interference, will be reported to the stewards who may impose a penalty up to exclusion

12.9 "Vehicle to Vehicle Alarm" system

(Recall of the Art. 29.1 of the Cross Country General Prescriptions)

The system "vehicle to Vehicle Alarm" (a device that signal to a competitor that he can be overtaken) must obligatorily be mounted on all the cars of the Competitors participants to the Baja. The modalities of rental and assembly on the vehicle are indicated in the www.hungarianbaja.com site.

No competitor with a car without the "Vehicle to Vehicle Alarm System" unit will be authorized to start.

a) This system must be in operation throughout the running of each Leg and must be connected directly to the battery of the vehicle.

The operation of the system is the responsibility of the competitor. If it is noted that the system is not in operation, through the fault of the crew, the following penalties will apply:

- **1 hour** for competitors classified among the top 20 in the general Car classification, the top 10 in the general Truck classification, and/or seeded drivers.

- **300 €** for the other competitors.

b) In a selective section, any vehicle running which has received several audible warnings within a given time and which has not pulled over to allow the other vehicle to overtake may be sanctioned at the Stewards' discretion, following examination of the downloaded data.

Depending on the circumstances, they may apply other penalties, possibly to the highest classified crew of the team to which the guilty crew belongs.

In case of dispute, the data from the Vehicle to Vehicle Alarm device is downloaded, after a written request to the clerk of the course.

12.10 Assistance in the Baja of an accident

(Recall of the Art. 29.2 of the Cross Country General Prescriptions)

a) All competitors must:

- Use a tracking system and a Vehicle to Vehicle Alarm system;
- Each competing vehicle must carry a red reflective triangle ;
- Each road book shall contain as the rear cover in A4 size (folded), a red 'SOS' sign and a green 'OK' sign.

b) It is reminded that ethics demand that a crew which sees that an accident has occurred must stop in order to provide assistance in the most appropriate manner until the rescue service arrives. It is also reminded that major means are implemented to shorten the intervention times.

c) In case of a serious accident and if at least one crew member is conscious and able to move by himself, he will have the obligation to:

- Trigger the alarm of the Vehicle to Vehicle alarm System through the AlarmBox by pushing on the covered switch bar in order to alert HQ.

12.11 Time Controls – Maximum Time allowed – Penalties

A maximum lateness of 15 minutes for every Road section and a total lateness of 30 minutes in road sections of a Leg is authorised. This lateness will be penalised at a rate of 1 minute per minute or fraction of minute according to the Art. 36.8 of FIA CCR General Prescriptions 2010.

The maximum time allowed as above may be modified at any moment by the Stewards, up on the proposal of the Clerk of the Course. Crews will be informed thereof as soon as possible.

12.12 T.C. exceeding Maximum time allowed – The lack of one or more T.C. – Penalties

Any lateness exceeding **fifteen (15) minutes** on the target time in a road section between two Time Controls, or a **total lateness exceeding thirty (30) minutes** at the end of each Leg will entail the application of a Fixed Penalty equal to **2 hours**.

Such fixed penalty will be applied also in the case of lack of transit to one or more Time Controls, and will be added to other eventual penalties, the fixed penalties of the Selective Section which has been done beyond the maximum time or not carried out (Art. 12.14), and the penalties for absence of Passage Controls Stamps (Art. 12.13.2).

The application of the fixed penalty for exceeding the maximum permitted lateness and/or for lack of T.C. may only be announced at the end of a Leg.

In order to benefit from the application of this Fixed Penalty crews must pass with their cars the end of Super Special Leg Time Control (Parc Fermé), the end of Leg 1 Time Control (Parc Fermé) and the end of Leg 2 Time Control (Parc Fermé) within the time scheduled for the closing of the control.

12.13 TIME CARD CHANGE DURING THE EVENT:

The Time cards will be issued at the Start of each Leg and each Section.

12.14 STARTING SYSTEM OF SPECIAL STAGES:

The timekeeping on the Special Stages will be completed to the second.

12.14. STARTING PROCEDURE FOR THE SPECIAL STAGE will be as follows:

On the start of the Special Stage the crew stops the car at the start control, the marshal notices in the time card the actual start time of the car (hour and minutes) and the start will be given by means of a light equipment. A two digit display will show continuously the time progressing.

The marshals will call out loud the 30, 15, 10 seconds then point towards the start equipment. Beginning from the 55 seconds, red lights will be flashed per every second, then at 00 seconds the red lights will go off and below, the green lights will go up. This will be the time to start. In case the equipment goes wrong the marshals will change to manual starting procedure. Any crew not impossible to start during the 20 seconds will be penalized with 2 minutes. If the participant can't leave the control zone the penalty may go as far as start refusal.

12.14.2 Starting order

After Leg SSS, and for the following legs, the start will be given following the order of the Selective Section Classification of the previous leg and every 2 minutes for the first 10 classified (art. 20.4.a of the FIA CCR General Prescriptions 2010).

If two or more selective sections have been run in the same Leg, the starting order of the next day's leg will be drawn up by cumulating the times of these selective sections.

In case of an ex aequo, priority will be given to the crew who achieved the fastest time in the 1st selective section (art. 20.3 of the FIA CCR General Prescriptions 2010).

Any delay in reporting to the start of the different Legs will be penalized at the rate of one minute per minute's delay. Vehicles arriving more than 30 minutes late will not be allowed to start (art. 20.8 of the FIA CCR General Prescriptions 2010).

12.15 Maximum time allowed in the Selective Sections

By each Selective Section a maximum time authorised for the respective Sections will be the following:

Selective Section 1 (Super Special) max. 30 '

Selective Section 2 max. 60 ' Selective Section 3 max. 150 '

Selective Section 4 max. 30 ' Selective Section 5 max. 60 '

Selective Section 6 max. 150 ' Selective Section 7 max. 30 '

Selective Section 8 max. 60 ' Selective Section 9 max. 150 '

Selective Section 10 max. 30 ' Selective Section 11 max. 60 '

Selective Section 12 max. 30 '

According to article. 3.24 of the FIA CCR General Prescriptions 2010, any crew exceeding these times will be considered as arriving with the control closed and will be imposed a penalty.

Maximum time allowed may be changed by the Clerk of the Course at the Stewards discretion in case of non-predictable circumstances (climate, modifications in section distance, etc..)

12.16 Selective Sections not completed within the maximum time allowed or not completed or not regularly completed - Penalties

The following penalties will be applied for each Selective Section not completed within the maximum time allowed or not completed or not regularly completed:

S.S. n. 1 (Super Special Stage) Fixed penalty **30'**

S.S. n. 2/5 Fixed penalty **60'**

S.S. n. 3/6 Fixed Penalty **120'**

S.S. n. 4/7 Fixed Penalty **60'**

S.S. n. 8/11 Fixed Penalty **60'**

S.S. n. 9 Fixed Penalty **120'**

S.S. n. 10/12 Fixed Penalty **60'**

The fixed penalties specified as above will be added to the maximum times of the Selective Sections concerned and to the other penalties set up.

For being classified with all the applied penalties, a crew will have to do with the pain of exclusion from the race:

- a) to have regularly carried out at least one Selective Section in the Leg 1 and one Selective Section in the Leg 2.
- b) to have started in all the legs of the rally
- c) to have started in the first Selective Section of every Leg
- d) to enter the Time Control of the end of every Leg, before closing time of the Control.

12.17. Early check-in at end of Leg

Early arrival at the end of Legs (SSS, 1st, 2nd) time controls will not be penalized.

12.17.1. It is strictly forbidden to enter or leave a control area from any direction other than specified by the Road-Book, or to re-enter a control area once checking in has taken place at this control.

12.18. Issue and collection of time cards

A time card will be given to each crew at the start of each Leg. This time card will be collected at the arrival of the same leg (Art. 34.1 of FIA CCR General Prescriptions 2010)

12.19. Reconnaissances

Reconnaissance of the route is totally forbidden. Possession of route notes or other informations different from those given by the Organization is forbidden. Penalty decision at Stewards' discretion.

The only official route is that set out in the Road-Book.

To help competitors, the Organizer will indicate intersections and features of the route by means of arrows and tapes. The Road-Book shall be, however, the only official document for the itinerary to be followed.

13.2 ACCESS TIMES FOR SERVICE VEHICLES

Service vehicles and other automobiles are allowed to enter the Service Park only if they are identified with service plate affixed on the vehicle as instructed by the organizer. If a service vehicle entered to service area, authorized to remain in area till the race car take part in rally. If a car withdrawn from rally, the service vehicles and race cars must be leave the service area till the end of relevant day. The maximum speed allowed in the Service Area is 30 km/h according the Art 31.2 of the FIA CCR General Prescriptions 2010.

13.3. OPERATION OF THE SERVICE AREAS

For safety reasons and the proper functioning of the Service Areas, entry will be permitted only to service vehicles showing the Plates supplied by the Organization.

Tampering with or falsification of these plates will lead to disqualification of the team to which these service vehicles belong, on the decision of the Stewards.

Plates will be placed in a visible area of the front windscreen of the vehicle.

The maximum speed allowed in the service parks is 30 km/h

13.3.1 Towing, pushing (or any other means allowing a vehicle to move other than through the normal mechanical operation of its engine) is prohibited, unless it is in order to bring a vehicle into the road or to clear the track or to exit the parc fermé, in the latter case with a 15 minute penalty.

13.3.2 Throughout the rally, servicing of a competing car may be carried out only in service parks. Repairs that may be carried out by a team using on-board equipment or equipment carried by another participant in the race are authorized along the whole route. Any other external servicing outside the authorized areas is forbidden and shall be penalized by EXCLUSION at the Stewards' discretion.

13.3.3 The event may be followed from the air after expressly authorized by the Organization Committee. The team must obtain also the necessary legal permits from the Hungarian Aeronautical Authority.

13.3.4 In all service zones for all competing cars should be used a protection sheet under the vehicles at least 5x4 meters. Soiling must not be remained on the site. All entrants must make sure that no contamination remains at the venue, these will be controlled by the marshals and the technical scrutineers!

The violation of these rules will be sanctioned by a penalty of 200 EUR/case.

13.4. REFUELLING

In the Service Park it is forbidden to refuel, that is mandatory only in the "Refuelling" zone.

After every Service Park there will be a Refuelling Zone (between two T.C.), scheduled in the Timing and indicated in the Road Book, for the "Refuelling" (time 15').

The competitors will have to follow the FIA CCR General Prescriptions 2010 rules. (Art. 31.4).

19. OTHER ANNOUNCEMENTS OF THE ORGANIZER

The On - Line GPS (LOCHNER) needs a permanent, stable 12V connecting. The crews have to check its perfect working during the whole route. The route taken by the crews will be checked at the finish of the Legs (or more often) by the organizing committee. The GPS and its competence will be controlled on the scrutineering.

The Road Book contains the GPS controlling signs. The prescribed track-line by the road book will be checked on the classification. Those who deviate from the route will receive 30 minutes penalty by missing or deviated GPS Controlling Signs which does not count into the Leg's limitation time.

Fixed penalty (Forfait penalty): crews, who cannot "perfectly"

continue the Leg's route for whatsoever reason, allowed to enter her own power (working engine), in the parc fermé of the leg till in these regulation published time for publication of provisional results, or one of the forthcoming regrouping Station till in the roadbook published entry time of first car from regrouping station.

These cars are allowed to continue the rallye considered the following penalties:

- crews without measured time get the particular selective section's maximum allowed time +30 minutes per selective sections,
- 30 minutes penalty per missing Control Zones, which are not in the Selective Section.

These "Forfait penalty" can be used only one time during one day (leg) of race.

The organiser will provide all entrants with new start numbers (3+1) and identification cards, which will only be valid at the HunGarian Baja event.

The location of the stickers are given by the diagram in the appendix of present regulation. The organiser will communicate the type of the advertisements in the form of a bulletin before the start of the administrative checks.

Service Park: repairing is only permitted in the Service area. There is a marked Refuelling Zone. The vehicles can be refuelled at the crew's only in the Refuelling Zone. Air assistance is forbidden between the start and finish of the Leg. Only cars with service boards can be in the Service Park. The Road Book contains the place of the Service Zones. In all service zones for all competing cars should be used a protection sheet under the vehicles at least 5x4 meters. Soiling must not be remained on the site. All entrants must make sure that no contamination remains at the venue, these will be controlled by the marshals and the technical scrutineers!

The violation of these rules will be sanctioned by a penalty of 200 EUR/case.

Please note that cars with service plates will only be allowed to enter the service zones.

The crews have to put their Identifying Cards on the car, which they will get on the administrative check (photos!!!). The infringement of these rules and the documents asked on the administrative check, the crews will not receive the permit for start.

Exceeding the maximum speed limit (30km/h) in the Service Area and the Refuelling Zones will be measured by the organiser, and it will be sanctioned with a fine and time penalty.

1km/h= 50 EUR + 10 seconds

In the case of changing in the supplementary regulation, the organizer will be send an official bulletin.

In all circumstances, drivers may only participate at the event under their own responsibility.

At the entire route of the event the national traffic rules must be respected.
