#### **Art. 4.6 Entry fee refunds**

The entry fee shall be refunded in full:

- if the event does not take place
- to teams whose entry application is rejected.

The organiser may partially refund entry fees if a competitor cannot take part in the event due to a duly proved case of force majeure.

#### **Art. 5. Insurance Cover**

Name of the insurance company: SRC SPECIAL RISK CONSORTIUM GMBH, Kuniberts kloster 7-9, D 50668 KÖLN.

The limit of the responsibility is 3.000.000 Eur.

- In case of an accident leading to insurance event, the competitor or his representative must make a written statement to the Clerk of the Course, the Competitors Relations Officer, or directly to the Organizer, within 24 hours. This statement must mention the accident circumstances, the names and addresses of the casualties, as well as contact details of the witnesses.
- Competitors are reminded that only damage caused by the organizers and named drivers are covered by the Organization's insurance policy. Loss or injury that may be suffered by the drivers themselves or participating vehicles is EXCLUDED.

- Irrespective of this Third Party insurance, entrants and drivers are free to take out the policies they deem fit on their own account and at their own discretion.
- Service vehicles, including those displaying the plates supplied by the Organization, shall under no circumstances be deemed participating vehicles. They are therefore not covered by the Organization's insurance policy and responsibility for them lies solely with their owners.
- The insurance cover will come into effect from the administrative checking and scrutineering for the Event and end upon the expiry of one of the following time limits, whichever is the later:
  - time limit for protests or appeals or the end of any hearing by the Stewards;
  - end of the administrative checking and postevent scrutineering;
  - end of the prize-giving.

The Organization refuses all responsibility stemming from the consequences of infractions of the law, regulations and decrees of Hungary, committed by Competitors or their service crew, which must be exclusively borne by them.

## **Art. 6. Advertising and Identification**

The organiser will provide each crew with the advertising and identification panels, which must be affixed to their vehicles in the stated positions prior to scrutineering. **It is not allowed to cut the panels.**

### **Art. 6.1 Obligatory organiser's advertising**

## **Art. 9. Administrative checks**

Before the Administrative Check, each crew must **Register** at Tesco parking lot (Fehérvári str.17.), where the Service stickers and Checklist will be provided.

### **Art. 9.1 Documents to be presented:**

To keep the time required for the administrative checks to the necessary minimum, make sure to bring and present the following documents:

- Competitors' licence
- Driver's and co-driver's competition licences (if one of the drivers should be the competitor, he must hold also a competitors' licence)
- Driver's and co-driver's ID cards/passports
- Driver's and co-driver's valid driving licences valid for the vehicle entered.
- ASN authorisation for foreign competitors (if required)
- Completion of all details on the entry form
- Car registration papers
- Competing vehicle's insurance cover

### **Art. 9.2 Timetable**

Individual times for each competitor for the administrative checks will be published on Sportity and [www.hungarianbaja.com](http://www.hungarianbaja.com) in a Bulletin.

A time control before the Administrative Checks (C1) will be arranged, according to the individualized timetable.

Any delay to the C1 control will be penalized as follows:

- From 1 to 15 minutes: 150€ fine
- From 16 to 30 minutes: 250€ fine
- From 31 to 60 minutes: 500€ fine
- More than 60 minutes: 500€ fine and report to the Stewards.

## **Art. 10. Scrutineering, Sealing and Marking**

See Article 23 and Article 24 of the FIA CCSR.

After Scrutineering, the Parc Fermé is mandatory for all cars which have passed scrutineering.

(Time: 10.08.2023 15:00-18:30, Location: VÁRPALOTA FŐTÉR, Szabadság Square)

### **Art. 10.1 Scrutineering, venue, and time**

#### **Art. 10.1.1 Scrutineering, mandatory documents**

- Cars' complete original FIA Homologation Document (if applicable)
- FIA Technical Passport
- SOS / OK board (DIN A3 format)

The installation of the tracking system and the NAV-GPS will be checked at scrutineering.

The complete original FIA homologation form / FIA Technical Passport and all other necessary certifications/documents must be available for final checks.

### **Art. 10.1.2 Timetable for scrutineering**

*Individual times for each competitor for the Technical Scrutineering will be published on Sportity and [www.hungarianbaja.com](http://www.hungarianbaja.com) in a Bulletin.*

*There will be a time control before the Scrutineering (C2). The competitors should check-in to this time control according the individual schedule.*

*Any delay to the C2 control will be penalized as follows:*

- From 1 to 15 minutes: 150€ fine
- From 16 to 30 minutes: 250€ fine
- From 31 to 60 minutes: 500€ fine
- More than 60 minutes: 500€ fine and report to the Stewards.

### **Art. 10.2 Drivers' safety equipment**

All items of clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g. HANS devices, must be presented for scrutineering. They shall be checked for compliance with Appendix L, Chapter III.

The cars must be equipped with the medical kit according to FIA CCRSR Appendix IV-1 and FIA Technical List n°83 and the survival kit according to FIA CCRSR Appendix IV-2.1 and the defined Safety Type (see SR Art. 1.5).

### **Art. 10.3 Installation of the Safety Tracking System and Navigation System**

#### **Art. 10.3.1 Safety Tracking System (FIA CCRSR Art. 12.1)**

All vehicles must **only** be fitted with the Safety Tracking System(s) provided by the Organiser. The instruction for the use of the Tracking System is in the Appendix 5 of these Supplementary Regulations.

*The system will be collected either by the crew or a representative and must be installed before the car is brought to scrutineering. All the damage caused for the rally safety tracking equipment will be invoiced afterwards. Returning will be at the entrance of Parc Ferme on Saturday, 12th August or at Rally HQ Secretary in case of retirement.*

#### **Art. 10.3.2 Navigation System (NAV-GPS)**

Navigation System (NAV-GPS – FIA CCR SR Art. 12.2)) The Safety Tracking System(s) provided by the Organiser have included in it the waypoints (WPP) defined by the Organiser as established in art. 11.11.3 of the Supplementary Regulations.

#### **Art. 10.3.3 Connection of the Systems (FIA CCRSR Art. 12.3)**

The specifications for the standard power connector are laid down in the FIA CCRSR Appendix VI. It is the competitor's responsibility to ensure that the Safety Tracking System(s) and the NAV-GPS always remain permanently connected and switched on with the antenna connected throughout the duration of the competition.

#### **Art. 10.3.4 GPS Data Logger**

Vehicles selected by the FIA after the publication of the entry list may be equipped with a GPS Data Logger to monitor their performances during the event.  
See FIA CCRSR Article 13.1.

#### **Art. 10.3.5 FIA Accident Data Recorder (ADR)**

(See Appendix J, Article 283-2, Accident Data Recorder)

An Accident Data Recorder (ADR) complying with FIA Standard 8872-2018 "Accident Data Recorder" (listed in Technical List no. 88) must be installed in T1 cars manufactured from 2016 that participate in any Championship event. The ADR must be installed in accordance with the FIA ADR Installation Specification and manufacturer user's manual.

### **Art. 10.3.6 FIA On-Board Surveillance Camera (FIA OBSC)**

Vehicles selected by the FIA may be equipped with an FIA OBSC to monitor all activities inside the vehicle during the event.

### **Art. 10.4 On-Board Cameras**

See FIA CCRSR Article 11.

*The request for the On-Board cameras must be indicated on the Entry Form and installed prior to the Technical Scrutineering, where it will be checked and identified by an adhesive decal provided by the Organiser (see Art. 11.2 of the FIA CCRSR).*

### **Art. 10.5 Electronic Equipment**

Any radio or electronic means of communication, or any other device not expressly permitted in FIA CCRSR regulations is forbidden on board the vehicles.

## **Art. 11. Other procedures and regulations**

### **Art. 11.1 Drivers' Briefing(s)**

See programme (SR Art. 3)

The participation of at least one crew member is compulsory.

### **Art. 11.2 Start Area**

There will be no pre-starting area organized. Competitors have to present themselves, along with their competition vehicles, to the first Time Control of the race (TC 0, see Appendix 1 of Itinerary) according to the Starting List and relevant time that will be communicated via DNB.

### **Art. 11.3 Ceremonial start procedures and order**

*On Thursday evening, everyone will exit from the Parc Fermé to the Starting Ceremony, based on the issued Start List. It is mandatory to return to the Parc Fermé afterwards.*

### **Art. 11.4 Electronic start procedure at Selective Sections**

The start of the selective section is happening based on an electric clock and lamp, connected to a false start alert system.

When the car arrives at the start line, the front of the car should be positioned behind a stick placed by the marshal to define the exact start position. One minute before the start time, but not before the car has stopped in its exact position, the marshal shall remove the stick and the crew shall refer to the automatic countdown clock. Any subsequent change of the car's position until its start time is not permitted and will be reported to the Stewards.

### **Art. 11.5 Finish procedures**

*At the end of Stage2, the crews must place the vehicles in Parc Fermé, located in Várpalota Fő tér, Szabadság square, according time schedule of the event on Saturday, 12<sup>th</sup> August.*

### **Art. 11.6 Permitted early check-in.**

Early-check in is allowed at TC2C and TC4A

### **Art. 11.7 Official time used during the event.**

*The official time is the GPS time. (GMT+1)*

### **Art. 11.8 Road books delivery**

The Organiser will issue coloured, printed Road Book as follows (See also program (SR Art. 3):

- At Administrative Checks: Road Book for Shakedown Stage.
- At Briefing: Road Book for Stage1: 18:00
- Entering Park Fermé at the end of Stage1: Road Book for Stage2

Competitors are noticed that all notes in all Road Books of any STAGE provided by the Organiser are considered as Waypoints. Competitors are advised to use a GPS-tripmeter in compliance with Art.12.4 of 2023 CCRSR.

## **Art. 11.9 Servicing of vehicles**

### **Art. 11.9.1 Service Areas / Bivouacs**

*Access to the Service Park will only be permitted for vehicles, accompanying team cars- showing the Service Stickers, provided by the Organizer at the Registration (Tesco parking lot, Fehérvári str.17.) 1pc Service sticker/team is provided by the Organizer.*

*Tampering with or falsification of these stickers will lead to disqualification of the team to which these service vehicles belong, on the decision of the Stewards. The stickers will be placed in a visible area inside of the front windscreen of the vehicle.*

*Car wash and Refuelling is strongly prohibited in the total area of the service park!!! The only possibility to wash the cars is in the official car wash company, just beside the service park.*

The speed of vehicles in the service parks/bivouacs may not exceed **20 kph**

From TC0 onwards, service of a competing car may be carried out in Service Areas (Service Parks and Bivouacs) and road sections as permitted under the FIA CCRSR.

### **Art. 11.9.2 Identification of team personnel**

In service areas, after the start of the competition, only 3 team personnel may work on a competing vehicle. They will be identified by distinctive armbands.

### **Art. 11.9.3 Service allowed in Selective Section**

In accordance with article 49 of the FIA CCR SR, any service is forbidden during Selective Sections. Only crews with FIA groups vehicles still in the competition for the current Stage/SS may assist each other.

### **Art. 11.9.4 Flexi Service**

*Not applicable.*

### **Art. 11.9.5 Fuel and Refuelling Zone**

Refuelling is permitted only in commercial fuel stations using fuel on sale to the public. Only the crew may carry out this procedure.

The Refuelling station authorised will be indicated in the Road Book with "FUEL STATION".

No additional refueling zone will be established.

#### Art.11.11.3 Electronic Control of Itinerary

According with article 14.2.1 of 2023 FIA CCR SR the itinerary of the event is defined in the Road Book by the road direction diagrams. ALL the diagrams of the Road Book will be considered as a PRECISE WAYPOINT (WPP) as defined by art. 43.7 of 2023 FIA CCR SR with a validation radius of 20 meters as established in table of art. 43.1.6 of 2023 FIA CCR SR: According with article 14.2 of 2023 FIA CCR SR, the observance of the road book and the road direction diagrams will be electronically controlled and these information are contained in the memory of the GPS tracking system provided by the organiser according article 12.1 of 2023 FIA CCR SR. The passage of the vehicle through each road direction diagram is registered by the GPS and it will be shown on the screen the number associated to this diagram in the road book. According article 14.2.1 of 2023 FIA CCR SR, competitors must pass through all road direction diagrams in chronological order and cannot drive back to get a previously missed diagram. At the end of each Stage, the GPS may be inspected to control the validation of the road book diagrams. In the event of an infringement, the penalties are set out in art. 43 - Appendix I "List of Penalties" of 2023FIA CCRSR



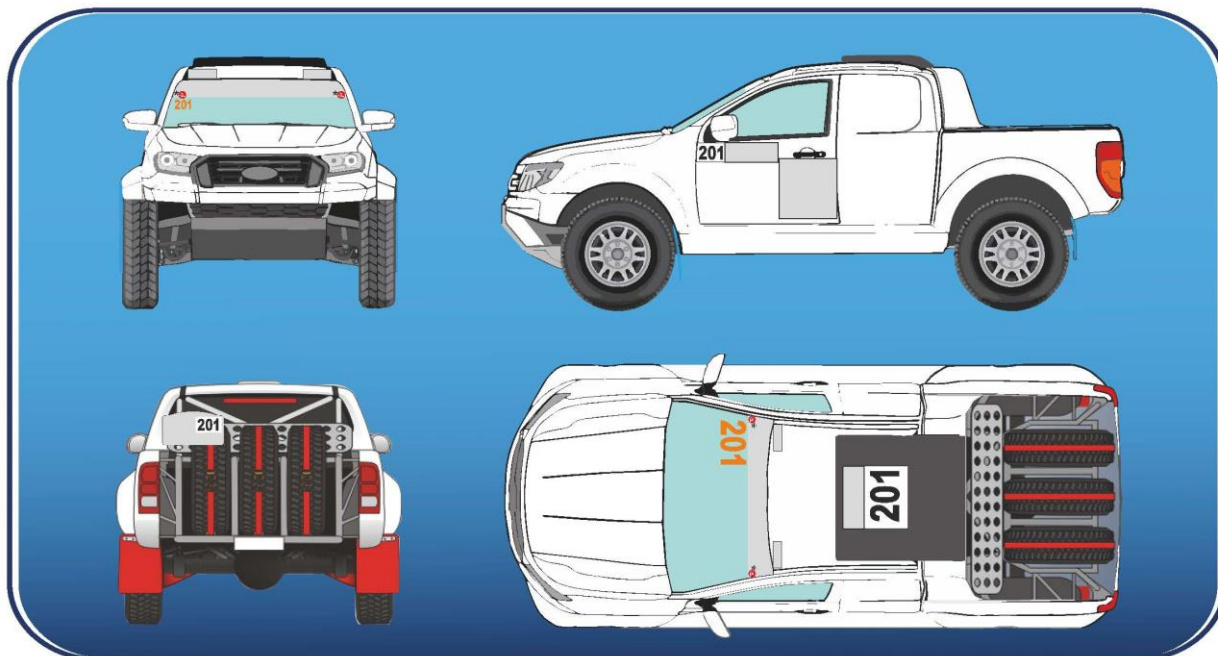

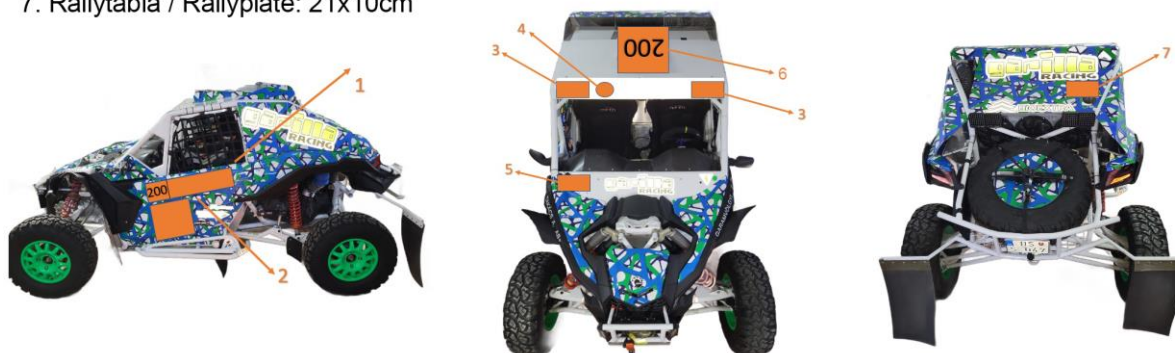

## **Appendix 4 – Extracts from FIA ISC Appendix L relating to overalls, helmets and any other safety requirements.**

---

All competitors are reminded of Appendix L of the FIA International Sporting Code, in particular its Chapter III - Drivers' Equipment.

### **Helmets (Appendix L, Chapter III, Art. 1)**

All crews must wear crash helmets homologated to one of the FIA standards listed in Appendix L.

### **Frontal Head Restraint (FHR, Appendix L, Chapter III, Art. 3)**

All crews must use FIA approved FHR systems homologated to FIA standard 8858.

Approved FHRs, anchorages and tethers are listed in Technical List N° 29.

See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.

### **Flame-resistant clothing (Appendix L, Chapter III, Art. 2)**

All drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard, technical List N°27, or 8856-2018, technical List N° 74 (Mandatory for all FIA priority drivers and their co-driver). Please pay special attention to the prescriptions of Art. 2 concerning embroidery and printing on flame-resistant clothing (manufacturer certificates etc.) as well as concerning the correct wearing of the clothing elements! See also FIA Cross-Country Rally Sporting Regulations Article 47.1.

### **Biometric Devices (Appendix L, Chapter III, Art. 2.1)**

Drivers may wear a device to collect biometric data during racing.

- If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.
- If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.

### **Wearing of jewellery (Appendix L, Chapter III, Art. 5)**

The wearing of jewellery in the form of body piercing or metal neck chains is prohibited during the competition and may therefore be checked before the start.

### **MEDICAL AND SURVIVAL KIT (Appendix IV of the Cross-Country Rally Sporting Regulations)**

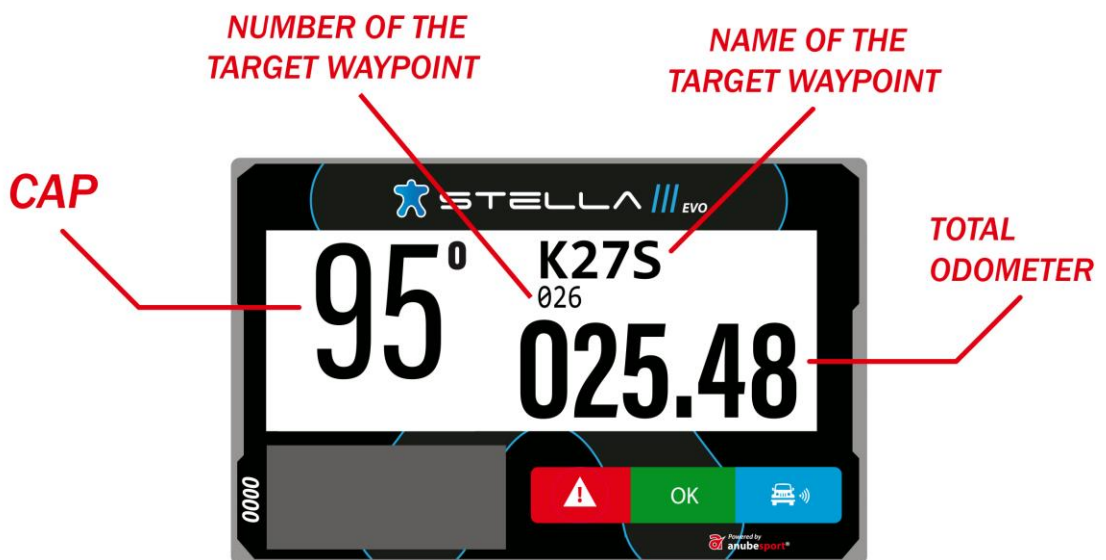

The radio-frequency antenna must be installed vertically to the roll cage bars (cars and SSV) and the forks (ATV). It is mandatory to use separators (included in the kit) to avoid contact with metallic parts and the carbon fibre that surrounds it.

Once the antennas are mounted, take the SMA connection cords to the base/mount where the STELLA III EVO will be installed.

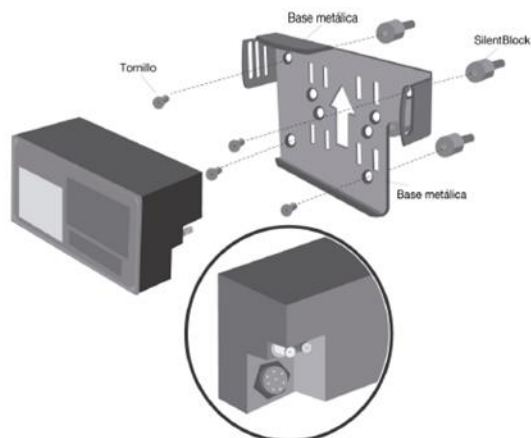
## 1. POWER CORD

- Connect the red wire to the positive end of the battery 12V(+), and the grey wire to the negative end (GRD). The power cord must be connected directly to the battery (without interruptions and without contact in the power supply).
- A 3A fuse (not included) should be connected to the red wire.
- Take the cord to the location in which the STELLA III EVO is to be installed. All other wires must be insulated, they cannot touch.



## 2. BASE/MOUNT

- Motorcycles and ATV: The mount can be attached to the handle bar or to a metal plaque close to the navigation system.
- Cars and UTV: The mount can be attached to the panel, or to the roll cage bars. STELLA III EVO buttons must be visible and accessible to the participant (pilot/navigator) even when they are sitting and with the seatbelts buckled.



### IMPORTANT

Leave the cords (antenna and battery) in place with at least 10 cm to spare for easy handling.

At least 5 cm of space behind the mount (bottom right corner) to allow space for power cord/connections.



### 3. GPS ANTENNA

The GPS antenna must be installed horizontally and without obstructions toward the sky. In cars and UTV, It can be mounted on the roof, the hood, or the dashboard. In motorcycles and ATV, attach to the mudguard. For additional firmness, it is recommended to cover it with adhesive tape (non metallic when mounting it to a metallic surface) and pull-up (when attached to soft or plastic parts).



### 4. ANTENNA IRIDIUM

The Iridium antenna must be installed horizontally and without obstructions toward the sky. In cars and UTV, It can be mounted on the roof, the hood, or the dashboard. In motorcycles and ATV, attach to the mudguard. For additional firmness, it is recommended to cover it with adhesive tape (non metallic when mounting it to a metallic surface) and pull-up (when attached to soft or plastic parts).



### 5. RF ANTENNA

The radio-frequency antenna must be installed vertically to the roll cage bars (cars and UTV) and the forks (motorcycles and ATV). It is mandatory to use separators (included in the kit) to avoid contact with metallic parts and the carbon fibre that surrounds it.

Once the antennas are mounted, take the SMA connection cords to the base/mount where the STELLA III EVO will be installed.
